- 3. *** That paragraph 3 of said By-Law Number 953 be amended by adding thereto clause C so that paragraph 3(c) shall read:
 - 3 (4). a mill rate on the assessed value of the lands

 designated in paragraph 2 (b). Which mill rate

 shall be fifteen percent of the rate referred to

 in 3 (b) as amended.


