

CORPORATION OF THE TOWNSHIP OF WIDDIFIELD

DISTRICT OF NIPISSING

BY-LAW NUMBER 957

BEING A BY-LAW TO AMEND BY-LAW NUMBER 953.

WHEREAS the Council of the Corporation of the Township of Widdifield deems it expedient to make certain amendments to By-Law Number 953 of the said Township.

THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WIDDIFIELD ENACTS AS FOLLOWS:

1. That paragraph 3 (a) of said By-Law Number 953 be amended to read as follows:

3(a). a foot frontage rate of nine cents per foot on lands designated in paragraph 2 (a) which front on or abut on the streets or parts of streets described in Schedule "C" to this by-law or connect to the water-mains constructed thereon.

2. That paragraph 3 (b) of said By-Law Number 953 be amended to read as follows:

3 (b). a mill rate on the assessed value of the lands designated in paragraph 2 (a).

3. That paragraph 3 of said By-Law Number 953 be amended by adding thereto clause C so that paragraph 3(c) shall read:

3 (c). a mill rate on the assessed value of the lands designated in paragraph 2 (b). Which mill rate shall be fifteen percent of the rate referred to in 3 (b) as amended.

4. That Schedule "C" of said By-Law Number 953 be amended by striking out the words "Johnston's Road" in the first column and inserting the words "Ski Club Road" so that Schedule "C" shall read :

5. Save as herein specifically amended the said By-Law Number 953 shall remain in full force and effect.

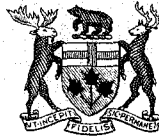

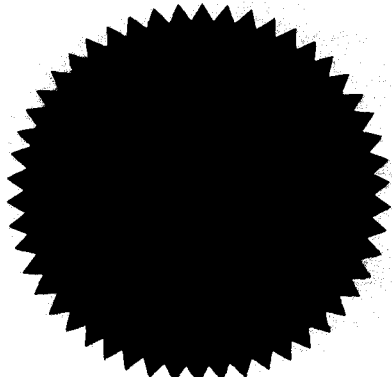
