

THE CORPORATION OF THE CITY OF NORTH BAYBY-LAW NO. 115-77

BEING A BY-LAW TO AMEND BY-LAW 1896 AS
AMENDED BEING A BY-LAW TO REGULATE TRAFFIC
IN THE LIMITS OF THE CITY OF NORTH BAY.

WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to amend By-law No. 1896 of the Corporation of the City of North Bay.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "F" (Parking Prohibited At Any Time) of By-law No. 1896 be hereby amended by:

(i) deleting therefrom the following:

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION WHERE PARKING IS PROHIBITED</u>
Sherbrooke St.	West	From McIntyre to Worthington St.

(ii) By adding thereto the following:

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION WHERE PARKING IS PROHIBITED</u>
Sherbrooke St.	East	From McIntyre to Worthington St.
Wyld St.	West	From McIntyre to Worthington St.
McIntyre St.	South	From Ferguson St. to a point 400 ft. west of Ferguson St., effective 1 March, 1978.

2. That Schedule "H" (Parking Restricted Limited Time) of By-law No. 1896 be hereby amended by deleting therefrom the following:

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION</u>	<u>PERIOD OF TIME</u>
Sherbrooke St.	East	McIntyre to Worthington St.	2 Hrs. 9:00 a.m. to 6:00 p.m.

3. That Schedule "J" Part B (One Hour Parking) of By-law No. 1896 be amended by

(i) deleting therefrom the following:

<u>STREET</u>	<u>SIDE</u>	<u>LIMIT</u>
Wyld St.	West	McIntyre St. to Worthing St. One Hour

(ii) By adding thereto the following:

<u>STREET</u>	<u>SIDE</u>	<u>LIMIT</u>
Wyld St.	East	McIntyre to Worthington St. - One Hour
Sherbrooke St.	West	McIntyre to Worthington St. - One Hour
McIntyre St.	North	From a point 43 ft. west of Ferguson St. to a point 165 ft. west of Ferguson St. effective 1 March, 1978.

4. That Schedule "J" Part C (Two Hour Parking) of By-law No. 1896 be hereby amended by adding thereto the following:

<u>STREET</u>	<u>SIDE</u>	<u>LIMIT</u>
Worthington St.	South	Wyld St. to Sherbrooke St. - Two Hours

5. That Schedule "J" Part D (Four Hour Parking) of By-law No. 1896 be hereby amended by adding thereto the following:

<u>STREET</u>	<u>SIDE</u>	<u>LIMIT</u>
Worthington St.	South	Sherbrooke St. to Fisher St. - Four Hours
Wyld St.	West	Worthington St. to First Ave. - Four Hours
Sherbrooke St.	East	Worthington St. to First Ave. - Four Hours

6. That Section 16 of By-law No. 1896 which authorizes restricted parking for municipal officials and police vehicles in the area of the City Hall located at 103-115 McIntyre St., West be amended by deleting effective 1 March, 1978, Clause No. 1 (a) which reads as follows:

"Clause No. 1 (a) - Municipal Officials and Police Vehicles

"An authorized municipal official and vehicles of the North Bay Police Department in that area set out on both sides of McIntyre Street opposite City Hall at any time daily, Monday to Saturday, inclusive."

7. That Schedule "K", Paragraph A (Fees for Parking at Parking Meters) of By-law No. 1896 be hereby amended by adding thereto under Civic Parkings Lots the following:

Civic Parking Lots

Civic Car Park No. 2
Civic Car Park No. 3
Civic Car Park No. 6
Civic Car Park No. 7

8. That Clause (b) of Schedule "K" of By-law No. 1896 be amended by deleting therefrom reference to Clause (c) so that the said Clause shall now read as follows:

Clause (b)

"One nickel for each thirty minutes or fraction thereof and two nickels or one dime for each sixty minutes or fraction thereof in excess of Thirty Minutes for parking at a parking meter in all parking meter zones other than those as set out in Clause (a) of this Schedule."

9. That Clause (c) of Schedule "K" of By-law No. 1896 which reads as follows be hereby deleted.

Clause (c)

"One nickel for each twenty minutes or fraction thereof or one nickel and one dime for each sixty minutes or fraction thereof in excess of twenty minutes for parking at a parking meter located in the following parking meter zones:

Civic Car Park No. 1
Civic Car Park No. 2
Civic Car Park No. 3
Civic Car Park No. 7

10. That except where it is otherwise indicated, the provisions of all clauses of this By-law shall take effect upon the final passing thereof.
