

BY-LAW NO. 1845

BEING A BY-LAW to amend By-law 1779, a By-law to authorize the revision of salaries of Department Heads, Secondary Department Heads not already covered by Union Agreement.

WHEREAS the Council of the Corporation of the City of North Bay has, by authority of Clause 1, Section (iii) of the Public Welfare Committee Report adopted at the regular meeting of City Council held Monday, March 3rd, 1958, authorized that By-law 1779 be amended to include Public Health and other Professional Nurses who are not covered by Union Agreement.




1. That By-law 1779 be amended to include Public Health and other Professional Nurses.

3. That the salary schedule with annual increments and effective dates as referred to in Schedule "A" attached hereto and forming part of this By-law be the salary schedule for Public Health and other Professional Nurses engaged and employed under the Board of Health of the City of North Bay.

To establish a minimum and maximum salary schedule with annual increments and effective dates for the positions listed herewith, being professional staff employees of the Board of Health in accordance with Clause 1 (3) of the Public Welfare Committee Report adopted by City Council in regular session Monday, March 3rd, 1958.

(4)	That the effective date be January 1st, 1958 and the employees indicated enjoy Consumers Price Bonus, Superannuation, and Group Hospitalization and Surgical Plan benefits, similar to other employees.			
(5)	That Cumulative Sick Pay Credits retroactive to January 1st 1956, less lost time during the period January 1st, 1956 to December 31st, 1957 be placed to their credit with full usual benefits from January 1st, 1958.
