

BY-LAW NO. 1793

BEING A BY-LAW to amend By-law No. 1456.

AND WHEREAS the Municipal Council of the City of North Bay deems it advisable to amend By-law No. 1456.

BY-LAW 1456 is amended and the following shall be enacted.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

(1) That Schedule (c) Paragraph (3) of By-law No. 1456 be amended and the following added thereto:

Excepting thereto and therefrom that part described as follows:

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of North Bay in the District of Nipissing in the Province of Ontario and being composed of part of Lot 646, according to a plan of sub-division filed in the Registry Office for the Registry Division of the District of Nipissing as Plan No. 21, and which said parcel or tract of land and premises may be more particularly described as follows:

COMMENCING at a point in the north-easterly limit of said Lot 646, distant 38 feet 6 inches, measured south-easterly thereon from the most northerly angle thereof; THENCE south-easterly along the north-easterly limit of the said Lot 646, 27 feet 6 inches, to the most easterly angle of Lot 646, THENCE south-westerly along the south-easterly limit of Lot 646, 92 feet 0 inches; THENCE north-westerly and parallel to the north-easterly limit of the said Lot 646, 27 feet 6 inches; THENCE north-easterly and parallel to the south-easterly limit of Lot 646, a distance of 92 feet 0 inches, to the point of commencement.

(2) That Schedule "D" be amended to add the area described as follows:

ALL AND SINGULAR that certain parcel or tract of land and premises situate lying and being in the City of North Bay in the District of Nipissing in the Province of Ontario and being composed of part of Lot 646, according to a plan of sub-division filed in the Registry Office for the Registry Division of the District of Nipissing as Plan No. 21, and which said parcel or tract of land and premises may be more particularly described as follows:

COMMENCING at a point in the north-easterly limit of said Lot 646, distant 38 feet 6 inches, measured south-easterly thereon from the most northerly angle thereof; THENCE south-easterly along the north-easterly limit of the said Lot 646, 27 feet 6 inches, to the most easterly angle of Lot 646; THENCE south-westerly along the south-easterly limit of Lot 646, 92 feet 0 inches; THENCE north-westerly and parallel to the north-easterly limit of the said Lot 646, 27 feet 6 inches; THENCE north-easterly and parallel to the south-easterly limit of Lot 646, a distance of 92 feet 0 inches, to the point of commencement.

(3) This By-law shall come into effect upon its approval by the Ontario Municipal Board.
