BY-LAW NO. 185-89

BEING A BY-LAW TO AMEND BY-LAW NO. 44-88 BEING A BY-LAW TO REGULATE PARKING ON MUNICIPAL PARKING LOTS

WHEREAS the Council of The Corporation of the City of North Bay deems it desirable to amend the regulating of parking on municipal parking lots.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS

- 1. a) That Section 2 of By-Law No. 44-88 be amended by adding the following after the words, "Lot No. 4" in the second line the words "and Parking Lot No. 2."
- 2. That Section 3 of By-Law No. 44-88 be amended by deleting the figure "2" from the second line.
- 3. That Section 3, s.s. (1) of By-Law No. 44-88 be amended by deleting the words, "one ten cent" in line 3 and inserting in lieu thereof the words "one dollar coin."
- 4. That Section 5 of By-Law No. 44-88 be amended by adding after the words "except the Parking Garage", the following, "and Lot 2", in line 2.
- 5. a) That Section 7(a) of By-Law No. 44-88 be amended by deleting the figure "2" from line 6 thereof and adding the following, "and 10" thereto and deleting the figure "5" in line 10 thereof and adding the following figure "7" thereto.
 - b) That Section 7 of By-Law No. 44-88 is hereby amended by adding the following paragraph (c):
 - (c) No person who holds a monthly permit issued pursuant to paragraph (a) of Section 7 shall park a vehicle in a reserved space in a parking lot unless the permit is visibly displayed in the front window of such vehicle.
- 6. That Section 8 of By-Law No. 44-88 be amended by deleting the figure "2" from line 4 thereof.
- 7. That Section 13 (a) of By-Law No. 44-88 be amended by adding after the words "Lot No. 4" in line 2 the words "and Lot No. 2" thereto and by adding after the words "Lot No. 4" in line 5 "and Lot No. 2".
- 8. That Section 13 (b) of By-Law No. 44-88 be amended by adding after the words "Lot 4" in line 2 the words "and Lot 2".
- 9. That Section 18 (a) be amended by deleting sub-sections (iii) and (iv) from By-Law No. 44-88 and inserting in lieu thereof, the following sections in lieu thereof:
 - "(iii) the procedure for making a voluntary payment of the penalty, which voluntary payment shall be \$3.00 providing payment is made within 10 days or a set fine approved pursuant to the Provincial Offences Act providing payment is made within fifteen days of the offence."
 - "(iv)" in the event of failure to make payment of \$3.00 within ten days or a set fine approved pursuant to the Provincial Offences Act within fifteen days exclusive of costs, process will be issued pursuant to The Summary Convictions Act or under The Provincial Offences Act, whichever is applicable."
