THE CORPORATION OF THE CITY OF NORTH BAY

<u>BY-LAW NO. 49-68</u>

BEING A BY-LAW FOR PROVIDING THE SUM OF \$100,785.00 FOR THE DEPARTMENT OF PARKS AND RECREATION OF THE CORPORATION OF THE CITY OF NORTH BAY TO DEFRAY THE COST OF PERMANENT IMPROVEMENTS AND EQUIPMENT FOR PARKS, RECREATIONAL AREAS AND PLAYGROUNDS IN THE CITY OF NORTH BAY.

THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY, PURSUANT TO THE PROVISIONS OF THE MUNICIPAL ACT, R.S.O. 1960, CH. 249, SEC.377, SUB-SEC.69, HEREBY ENACTS AS FOLLOWS:

1. THAT capital funds in the sum of \$100,785.00 be provided during the year 1968, for the Department of Parks and Recreation of the City of North Bay, for permanent improvements and equipment for parks, recreational areas and playgrounds in the City of North Bay, and more particularly set forth and described in Schedule 'A' to this By-Law.

2. THAT the Treasurer of The Corporation of the City of North Bay is hereby authorized to borrow from time to time, from any bank or person by way of promissory note or notes, bearing interest at the rate of not more than seven and one-quarter percent $(7\frac{1}{4}\%)$ per annum, temporary advances of money to meet the cost of the aforesaid expenditures, pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowings exceed the amount limited in this By-Law.

3. THAT the debentures to be issued for payment of the cost of the aforesaid permanent improvements and equipment shall bear interest at such rate as the Council may determine, and shall be made payable within ten (10) years on the instalment plan.

4. THIS By-Law shall not become effective until approval, in writing, has been secured from the Ontario Municipal Board, pursuant to Sec.64(1) of The Ontario Municipal Board Act, R.S.O. 1960, Ch.274.

1. that the said Corporation may borrow the whole or any part of the said sum of \$100,785.00 as required




