

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 134-71

WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to amend By-law No. 1896 of the Corporation of the City of North Bay.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Schedule "C" of By-Law 1896 aforesaid is hereby further amended by adding thereto the following:

Songis Road	Road Allowance between Lots 6 & 7 Township of Widdifield
Birchwood Road	At every intersecting street between Gormanville Road and Jane Street
Parkwood Drive	At every intersecting street between Tackaberry Drive and Pinewood Road
Oakwood Avenue	Cedargrove Drive
Pinewood Road	At every intersecting street north of Jane Street
Fodor Street	At every intersecting street between Lakeshore Drive and Campbell Avenue
George Street	Lee Avenue
Galt Street	Cedar Street
Morin Street	Cedar Street
McLeod Street	Cedar Street, Eva Street, Rose Avenue
Kehoe Street	Eva Street
Ann Street	McLaren Street
Queen Street	At every intersecting street between Regina Street and Charles Street
Leask Avenue	Beth Avenue and Charles Street
Marshall Park Drive	At every intersecting street between Marshall Avenue and Lakeshore Drive

2. Schedule "F" of By-Law 1896 aforesaid is hereby further amended by adding thereto the following:

McIntyre Street	South	From a point 150 feet west of Wyld Street to a point 305 feet west of Wyld Street
McIntyre Street	South	From a point 185 feet west of Ferguson Street to a point 375 feet west of Ferguson Street
Worthington Street	North	From a point 310 feet east of Fraser Street to Fraser Street
Timmings Street	Both	Main Street to C.P.R. Tracks
McIntyre Street	South	From a point 200 feet west of Plouffe Street to Plouffe Street
