
BY-LAW NO. 17-69

BEING A BY-LAW FOR PROVIDING THE SUM OF \$60,000.00 FOR THE PURPOSE OF ACQUIRING BY PURCHASE THE EAST PART OF LOT 129 ON THE SOUTH SIDE OF McINTYRE STREET WEST AS SHOWN ON REGISTERED PLAN NO. 10 FOR THE CITY OF NORTH BAY.


THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY, PURSUANT TO THE MUNICIPAL ACT, R.S.O. 1960, CHAPTER 249 SECTION 377 PARAGRAPHS 67 AND 68, HEREBY ENACTS AS FOLLOWS:

1. THAT capital funds in the sum of \$60,000.00 be provided during the year 1969 for the purpose of acquiring by purchase the east part of Lot 129 on the south side of McIntyre Street West as shown on registered Plan No. 10 for the City of North Bay to be placed under the management and control of the North Bay Parking Authority.
2. THAT the Treasurer of The Corporation of the City of North Bay agree with any bank to borrow the aforesaid sum of \$60,000.00 by way of a term promissory note for a period of not more than five years bearing interest at the rate of not more than seven and one quarter per cent (7¼%) per annum.
3. THIS BY-LAW shall take effect upon the final passing thereof and upon receiving the approval of the Ontario Municipal Board.

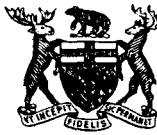

THE BOARD ORDERS, under and in pursuance of the legislation hereinbefore referred to, and of any and all other powers vested in the Board, that the said



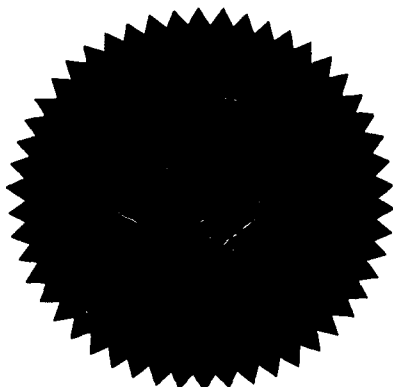

2. that the said Corporation may borrow the whole or any part of the said sum of \$10,000.00 as required pending receipt of subsidies or of moneys to be received from any other source, and
3. that the Corporation and the Parking Authority in exercising any power approved by this order shall comply with all statutory and other legal requirements related thereto.

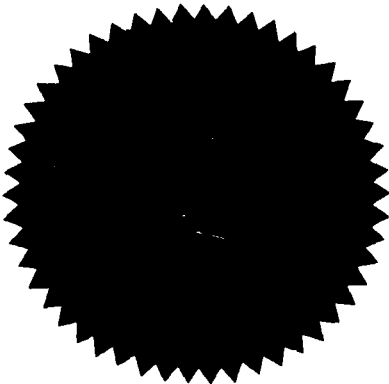
