BY-LAW OF MUNICIPAL CORPORATION

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW No1082
Whereas by Section 334 of The Municipal Act the Corporation is empowered to authorize the Head and Treasurer to borrow such sums as the Council may deem necessary to meet, until the taxes are collected, the current expenditures of the Corporation for the year, including the amounts for sinking fund, principal and interest falling due within the year upon any debt of the Corporation, school purposes, special rate purposes and for meeting requirements of any board, commission or body and other purposes for which the Corporation is required by law to provide.
AND WHEREAS the Council of the Corporation deems it necessary to borrow the sum of 100,000,00 from THE ROYAL BANK OF CANADA for purposes aforesaid.
AND WHEREAS the revenues of the Corporation for the last fiscal year ending December 31st. 1932., exclusive of moneys borrowed and moneys derived from the sale of debentures in that year, totalled \$786.465.00
AND WHEREAS the amount heretofore borrowed by the Corporation (if any) for the purposes aforesaid, together with the amount hereby authorized to be borrowed, does not exceed the amount which may be lawfully borrowed under Section 334 of The Municipal Act.
BE IT THEREFORE ENACTED by the Municipal Council of the Corporation of the City as follows:—
(1) That the Mayor (Warden of County; Mayor of City or Town, or Reeve of Village or Township) and the Treasurer of the Corporation be and they are hereby authorized, under the seal of the Corporation, to borrow from THE ROYAL BANK OF CANADA the sum of One hundred thousand
(\$100.000.00) from time to time for purposes aforesaid.
(2) That the said Mayor and the Treasurer aforesaid be and they are hereby authorized to pay or allow the said Bank interest on the sum or sums so borrowed at the rate of SIX(6%) per cent. per annum, which may be paid or allowed in advance by way of discount howsoever as they deem best.
(3) That the said Mayor and the Treasurer aforesaid be and they are hereby authorized, as security for such loan, to give to the said Bank promissory notes or other forms of agreement of the Corporation, signed by them and sealed with the seal of the Corporation. The said

sum or sums so to be borrowed shall be mad	e payable on or b	efore the 31st.	
day of December ne	ext; provided, he	owever, that the promissor	y note or notes
of the Corporation, if any given therefor and	d if made payable	e before the said 31.s.t	
day of December	may be renewed	by the said Mayor	
and Treasurer from time to time, but no res	newal thereof sha	ll fall due later than the sa	id
31st. day of December	next. N	No such renewal, however,	shall be deemed
to be satisfaction to the said Bank of any a	dvance or interes	t, but as evidence only of in	debtedness.
(4) The revenues of the Corporation a	are hereby charge	ed with repayment of the su	ıms so borrowed
and THE ROYAL BANK OF CANADA	shall have a lie	n upon the revenues so ch	narged until the
charge is satisfied.			
(5) That the said Mayor		and the Treasurer aforesa	aid be and they
are hereby authorized to enter into and exe	ecute on behalf of	the Corporation, under its	Corporate Seal,
an agreement or agreements, charging, as a	foresaid, the reve	enues of the Corporation wi	th repayment of
