

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 85-71

BEING A BY-LAW TO REMOVE CERTAIN LANDS
FROM PART-LOT CONTROL.

THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY PURSUANT TO SECTION 26, SUBSECTION (5) OF THE PLANNING ACT, R.S.O. 1960, CHAPTER 296, AS AMENDED, ENACTS AS FOLLOWS:

Subsection 4 of Section 26 of The Planning Act, R.S.O. 1960, Chapter 296, as amended, does not apply to the Registered Plan and lots described as follows:

F I R S T L Y :

FIRSTLY:

Lots 2188, 2189, 2190, 2208, 2209, 2210, 2211, 2212, 2213, 2214, 2215, 2216, 2217, 2218, 2219, 2220, 2221, 2222 and 2223, and the South Half of Lot 2207, and the South Half of Lot 2187, in the Township of Widdifield, now City of North Bay, as shown on Plan M-177, filed in the Office of Land Titles at North Bay.

SECONDLY:

Lots 2224, 2225, 2226, 2231, 2232, 2233, 2234, 2235, 2236, 2237, 2238, 2239, 2240, 2241, 2242, 2243, 2244, 2245, 2246, and the North Half of Lot 2227, and the North Half of Lot 2247, in the said Township of Widdifield, now City of North Bay, as shown on Plan M-177, filed in the Office of Land Titles at North Bay.

S E C O N D L Y :

In the Township of Widdifield, now City of North Bay, in the District of Nipissing, and Province of Ontario, namely:-

Parts of lanes, as shown on Plan M-177, in the Township of Widdifield, now City of North Bay, said Parts shown on a Plan of Survey recorded in the Office of Land Titles at North Bay, as Plan 36R-2497, and designated thereon as Parts 3, 11, 16 and 24.

T H I R D L Y :

FIRSTLY:

Lots 2093, 2094, 2095, 2096, 2097, 2098, 2099, 2100, 2101, 2102, 2103, 2104, 2105, 2111, 2112, 2113, 2114, 2115, 2116, 2117, 2118, 2119, 2120, 2121, 2122, 2123, 2124, 2125 and 2126, in the said Township of Widdifield as shown on Plan M-177, filed in the Office of Land Titles at North Bay.

SECONDLY:

The North 14.78 feet from front to rear of Lot 2127, having a frontage on Olive Street on said Plan M-177.

F O U R T H L Y :

In the Township of Widdifield, now City of North Bay, in the District of Nipissing, and Province of Ontario, namely:-

Those portions of lands in the said Township of Widdifield,


as shown on Plan M-177, filed in the Office of Land Titles at North Bay, said parts shown on a Plan of Survey recorded in the said Land Titles Office as Plan 36R-2530, and designated thereon as Parts 4 and 9.

ALL SUBJECT TO THE RESERVATIONS IN THE ORIGINAL GRANT FROM THE CROWN, AS VARIED BY STATUTE, AND TO THE PROVISIONS OF THE PUBLIC LANDS ACT.

READ A FIRST TIME IN OPEN COUNCIL THIS 19TH DAY OF JULY, 1971.

READ A SECOND TIME IN OPEN COUNCIL THIS 19TH DAY OF JULY, 1971.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 19TH DAY OF JULY, 1971.
