

BY-LAW NO. 1273

BEING A BY-LAW to repeal certain By-Laws of the Corporation of the City of North Bay.

WHEREAS certain By-Laws of the Corporation of the City of North Bay are conflicting and should be repealed.

AND WHEREAS the Council of the Corporation of the City of North Bay deem it advisable to repeal said By-Laws.

THEREFORE BE IT ENACTED AND IT IS HEREBY ENACTED BY THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY AS FOLLOWS:

1. THAT the following By-Laws be repealed, that is to say:

By-Laws Numbers 54, 98, 153, 155 regulating Circuses, Merry-go-rounds, etc.

By-Law No. 70 regulating Shooting Galleries.

By-Laws Numbers 254, 933 and all other By-Laws or parts of By-Laws appointing Magistrates.

By-Law No. 269 and former By-Laws dealing with regulating and licensing Tobacco, Cigars and Cigarettes.

By-Law No. 275 regarding number of Councillors.

By-Law No. 1185 and all former By-Laws dealing with appointment of City Solicitor.

By-Law No. 520 dealing with date of Theatre License.

By-Law No. 713 and all former By-Laws dealing with the establishment of a Market.

By-Law No. 767 and former By-Laws dealing with closing of Barber Shops.

By-Law No. 491 - Disposal of Fines and Penalties re Ontario Temperance Act.

By-Law No. 621 and all former By-Laws dealing with early closing other than Barber Shops.

By-Laws Numbers 358 and 431 - appointment of Medical Officer of Health.

By-Laws Numbers 366 and 751 - appointing Treasurer prior to Mr. Jas. A. Smith.

By-Law No. 578 - Advance Poll.

By-Law No. 626 - Gasoline Pumps and Tanks.

By-Law No. 657 - Public Health Nurse.

By-Laws Numbers 617, 671, 676 and 753 - Officer to enforce the Ontario Temperance Act.

All By-Laws appointing Mr. E. R. Valiant as an employee of the Corporation of the City of North Bay.

By-Law No. 1144 and all former By-Laws or Parts of By-Laws appointing Mr. A. C. Amos as Assessment Commissioner.

All By-Laws or Parts of By-Laws, other than By-Law No. 847 and No. 1205 dealing with the Police Department or Police Force.
