

CONSTRUCTION BY-LAW NUMBER 1064

BY-LAW to authorize the construction of re-tread pavement on various streets as a local improvement under the Provisions of the Local Improvement Act.

WHEREAS, J. W. Richardson, S. Veraldi, F. A. York, P. Riddler, J. P. Hansen, A. L. Rooks, D. J. Morland, John Brown, J. A. Johnston, A. W. King, A. B. McKenzie, E. J. Corbeil, C. J. Neil, and others have petitioned the Council to construct, as local improvements the works hereinafter described, and the Clerk has certified that the petitions are sufficient and it is expedient to grant the prayer of the petitions in the manner hereinafter provided.

THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. THAT re-tread pavement be constructed on certain streets in the City of North Bay as set out in Schedule "A" hereto attached, and which forms part of this By-Law as a local improvement under the Provisions of the Local Improvement Act.
2. THAT the engineer of the Corporation do forthwith make such plans, profiles and specifications and furnish such information as may be necessary for the making of a contract for the execution of the work.
3. THAT the work shall be carried on and executed under the superintendence and according to the directions of such Engineer.
4. THAT the Mayor and Clerk of the Corporation are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm, or corporation, subject to the approval of the Council which may be declared by a resolution.
5. The Treasurer may, subject to approval of the Council, agree with any bank or person for temporary advances of money to meet the costs of the construction pending the completion of it.
6. The Special assessment shall be paid by five equal annual instalments.
7. The debentures to be issued for the loan to be effected to pay for the costs of the work when completed, shall bear interest at (6%) Six per cent per annum, and shall be made payable within five years on the instalment plan.
8. Any person whose lot is specially assessed may commute for a payment in cash the special rates imposed thereon by paying the portion of the costs of construction assessed upon such lot without interest forthwith after special assessment Roll has been certified by the Clerk.
