

BY-LAW NO. 1967.

BEING A By-LAW of the Corporation of the City of North Bay requiring the closing of Barber Shops during certain hours and for regulating the operation of Barber Shops.

WHEREAS for the purposes of this By-law wherever an expression of time occurs it shall be taken to mean Standard Time or Day-light Saving Time, whichever system of time is currently being observed in the City of North Bay.

THEREFORE THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That all Barber Shops within the City of North Bay shall be closed at the hour of (6) six o'clock in the afternoon of each day in each week of the year and said shops shall remain closed from the said hour of (6) o'clock in the afternoon until (5) five o'clock on the following morning, except as hereinafter provided.
2. That all Barber Shops within the City of North Bay shall be closed between the hours of (6) six o'clock on the afternoon of Tuesday and (5) five o'clock in the forenoon of the Thursday next following in each and every week during each and every year, except during such periods of the week immediately preceding Good Friday, Christmas Day and New Years Day in each and every year.
3. That no Barber Shops shall be opened in a place of residence within the City of North Bay unless and until such Barber Shop complies with the requirements of the By-laws of the City of North Bay.
4. That no person shall engage in the business of, or operate, a Barber Shop within the City of North Bay, without first having obtained a certificate from the Department of Labour, except those persons who, with the approval of the Department of Labour, are working as apprentices to such Barbers.
5. That every barber within the City of North Bay who has been awarded a certificate from the Department of Labour shall exhibit the same in a conspicuous position on the premises where he carries on business as a barber and where it may be viewed by any customer.
6. That By-law Nos. 1409 and 1161 and any amendments thereto are hereby repealed.
7. *Doc* That this by-law shall take effect on the date of its passing *Doc* ~~approval in writing by the Department of Health and shall be subject to the provisions of the Factory, Shops and Office Building Act and the Public Health Act.~~ *Doc*
8. That every person who contravenes any of the provisions of this by-law shall, upon conviction thereof, forfeit and pay at the descretion of the Convicting Magistrate, a penalty not exceeding (exclusive of costs) the sum of \$50.00 (fifty dollars) for each offence.
