

BY-LAW NO. 1515

BEING A by-law to amend by-law no. 1446, a by-law known as "THE ZONING BY-LAW".

WHEREAS the Municipal Council of the City of North Bay deems it advisable to amend said by-law no. 1446.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT the following described property be eliminated from Schedule C of said by-law and added to Schedule D as paragraph 3(a);
3 (a) ALL LOTS FRONTING ON CASSELLS STREET AND TROUT LAKE ROAD BETWEEN THE NORTH LIMIT OF OLIVE STREET AND THE SOUTHERLY LIMIT ON FRANCIS STREET PRODUCED.
2. That the following described property be eliminated from Schedule A, Paragraph 1, of said by-law and added to Schedule D,
14. ALL THAT PROPERTY BOUNDED BY SCOLLARD; BEATTIE; VIMY AND BROWNING STREET FOR HOSPITAL AND NECESSARY ACCOMPANYING BUILDINGS ONLY FOR THE PROTECTION OF THE HEALTH OF THE CITIZENS.

READ A SECOND TIME IN OPEN COUNCIL THIS 7th DAY OF APRIL, 1948.

- 14. All that property bounded by Scollard, Beattie, Vimy and Browning Streets for Hospital and necessary accompanying Buildings only for the protection of the Health of the Citizens.
