

BY-LAW NO. 451

BEING A BYLAW TO PROVIDE FOR THE CLOSING OF PORTIONS OF  
McINTYRE AND SOUTH STREETS IN THE TOWN OF NORTH BAY

WHEREAS it is deemed advisable that certain portions of  
McIntyre Street and South Street in the town of North Bay,  
should be closed.

AND WHEREAS notice of the intention of the Municipal  
Council of the town of North Bay to close such portions of  
the said streets, has been duly advertised in a local paper  
once a week for four weeks, in accordance with the require-  
ments of the Municipal Act.

AND WHEREAS all parties who claim that their property  
would be prejudicially affected by the passing the said  
bylaw, and who have petitioned the Municipal Council to be  
heard in connection therewith, have been so heard by the  
said Municipal Council.

AND WHEREAS in the opinion of the Municipal Council it  
is in the interests of the Municipality that the said bylaw  
should be passed.

BE IT ENACTED AND IT IS THEREFORE HEREBY ENACTED BY THE  
MUNICIPAL COUNCIL OF THE TOWN OF NORTH BAY, AS FOLLOWS:

1. That from and after the passing of this bylaw the  
portions of McIntyre and South Streets in the town of North  
Bay, hereinafter described, be and are hereby closed, namely,

ALL AND SINGULAR those certain parcels or tracts of land  
and premises, situate, lying and being in the town of North Bay  
in the District of Nipissing and Province of Ontario, and being  
composed of parts of McIntyre and South Streets in the said  
town, the said streets being shown on a plan of subdivision of  
part of lot Nineteen in Concession "D" of the township of  
Widdifield, prepared by John H. Shaw, O. L. S. dated at North  
Bay, Ont. June 12th, 1903, and registered in the Registry Office  
for the District of Nipissing on July 22nd 1903, and which parcels  
may be more particularly described as follows, that is to say:

FIRSTLY: (part of McIntyre Street) being all that part of  
the said McIntyre Street lying to the north west of the right  
of way of the Temiskaming and Northern Ontario Railway, and  
to the south east of a line drawn across said street from the  
north easterly angle of lot Thirty-six to the south westerly  
extremity of the line between lots Thirty-nine and Forty (all  
said lots being shown on the said plan)

SECONDLY (Part of South Street). Being all that part of  
the said South Street lying to the south west of the said  
McIntyre Street and to the north east of a line drawn across  
the said street from the north westerly extremity of the line  
between lots Ten and Thirty-six to the south easterly extremity  
of the line between lots eleven and thirty-five (all said lots  
being shown on the aforesaid plan) the parcels herein described  
being shown on a plan of survey prepared by H. M. Anderson O.L.S.  
and dated at North Bay, Ont. Sept. 7th, 1915, the same hereto  
attached.

THIS Bylaw shall take effect immediately after the  
passing thereof.
