BY-LAW NO. 2000-65

**BEING A BY-LAW TO AMEND TRAFFIC BY-LAW
NO. 131-93 (SCHEDULE 2 - NO PARKING AREA OAK ST.);
(STOP SIGNS - SCHEDULE 10 SKI CLUB ROAD) AND
(NO LOADING - SCHEDULE 17 OAK STREET)**

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45 authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1990, Chapter H-S, as amended, authorizes the Council to pass by-laws regulating traffic on highways;

AND WHEREAS it is deemed expedient to regulate or prohibit certain traffic and to regulate or prohibit certain parking within the limits of the City of North Bay;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule 2 to Traffic By-law No. 13 1-93 is hereby amended by deleting the following thereto:

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
Oak Street E.	North	A point 50 metres east of Ferguson Street and a point 95 metres east of Ferguson Street

2. That Schedule 2 to Traffic By-law No. 13 1-93 is hereby amended by adding the following thereto:

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
Oak Street E.	North	A point 64 metres east of Ferguson Street and a point 95.5 metres east of Ferguson Street

3. That Schedule 10 to Traffic By-law No. 13 1-93 is hereby amended by adding the following thereto:

Ski Club Road and Bolton Drive on all three approaches

4. That Schedule 17 to Traffic By-law No. 13 1-93 is hereby amended by deleting the following thereto:

<u>STREET</u>	<u>SIDE</u>	<u>BETWEEN</u>
Oak Street E.	North	50 metres east of Ferguson Street and 65 metres east of Ferguson Street


5. That Schedule 17 to Traffic By-law No. 13 1-93 is hereby amended by adding the following thereto:

<u>STREET</u>	<u>SIDE</u>	<u>BETWEEN</u>
Oak Street E.	North	54 metres east of Ferguson Street and 64 metres east of Ferguson Street
