

BY-LAW NO. 2146

BEING A BY-LAW of the City of North Bay to provide for the establishment of a policy of an award to resident students of North Bay who bring high honour to the City by being named "Ontario Scholar" by the Department of Education of Ontario.

AND WHEREAS it is deemed expedient by the Council of the Corporation of the City of North Bay to honour such student or students of the municipality who have attained high scholastic standing while attending and upon graduation from the several secondary schools of the City of North Bay by being named an "Ontario Scholar" thus bringing great honour to the City.

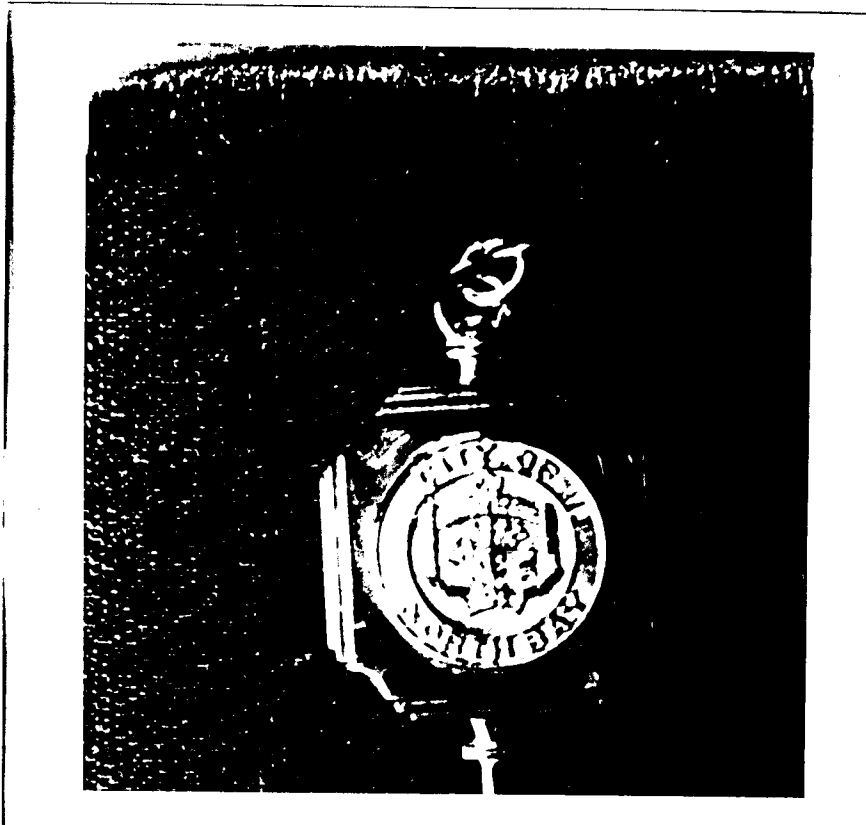
NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That a key as described in Schedule "A" attached to and forming part of this by-law, and being of 10k gold quality, be adopted as a lasting and personal memento of the academic accomplishment of each such North Bay resident student or students who has been named "Ontario Scholar" by the Department of Education of Ontario, past, present and future, and for presentation publicly to each such student at the first appropriate commencement exercise.
2. That a certificate of award as described in Schedule "B" attached to and forming part of this by-law, be adopted. Such certificates are to be framed and presented to the Secondary School of the City of North Bay from whence the "Ontario Scholar" or Scholars graduated, as a lasting record of the scholastic accomplishment of such student.
3. That the use of such keys and such certificates is hereby reserved exclusively as an award for academic achievement by resident students of the North Bay Secondary Schools who have been named "Ontario Scholar" by the Department of Education of Ontario.
4. That upon being advised by the Principal or Principals of any of the North Bay Secondary Schools of the names of resident students who have attained the honour of being named an "Ontario Scholar" the Clerk of the City of North Bay shall proceed without delay to have the necessary keys and certificates prepared for presentation to the student and school concerned, and maintain at all times a minimum quantity of 10 keys and certificates.
5. That the Treasurer will provide adequate funds each year in a separate account of the annual budget to make available the keys and certificates required by the City Clerk.
6. That a "Resident Student" means a student whose parents are listed as tenants or owners in the assessment records of the City of North Bay for the academic year the student in question was named an "Ontario Scholar" by the Department of Education of Ontario.
