City of North Bay Residential Low-flow Toilet Replacement Rebate Application Form

The City of North Bay is offering a \$50 rebate for the purchase of a maximum of two low flow toilets that are replacing existing, less efficient toilets. The rebate program is available exclusively for residential units located within the City of North Bay that are connected to the municipal water system.

Properties will receive a maximum of two rebates per account. For instance, if the property has one account and multiple units, the property would be eligible for a maximum of two rebates only.

To be eligible for the rebate offer, the Applicant must:

- Purchase and install an eligible low flow WaterSense toilet as approved by the City of North Bay;
- Fill out and sign the application form and submit it with the original sales receipt.

NOTE: 1. The program does not apply to new construction, or new bathroom additions; it must be a replacement toilet.
2. The City reserves the right to an on-site inspection of the new toilet, if required.

In consideration of receiving the rebate under the City of North Bay Residential Low-flow Toilet Rebate Program, the undersigned acknowledges and agrees:

1. That the City of North Bay may deny any application that does not meet Program requirements, which can be obtained by visiting www.northbay.ca or by calling the Customer Service Centre at 705-474-0400;
2. That the installation of the water efficient toilet indicated in this Application Form has been completed. The toilet must be installed prior to submission of rebate request. The installation date must be included on the application;
3. That the Application form must be completed correctly and in full in order to permit the City to verify the information provided;
4. That the City of North Bay or its agents may inspect all properties participating in this Program in order to confirm the information provided by the applicant;
5. That the City of North Bay does not guarantee or warranty (i) the performance of any toilet; (ii) that its installation will be free of defects; (iii) the quality of workmanship;
6. That the rebate is in the form of a credit on the water account;
7. That if this Application contains any material misstatement or misrepresentation, or if the Applicant breaches any of term or condition contained herein the credit on the water account will be reversed;
8. The City of North Bay reserves the right to alter or discontinue the program at any time. Submission of an application does not guarantee a rebate.
