## BY-LAW NO. 190-79

BEING A BY-LAW TO AUTHORIZE ACQUISITION OF LAND BY EXPROPRIATION.

WHEREAS the Council of The Corporation of the City of North Bay deems it necessary to acquire certain lands by expropriation to permit construction of the Chippewa Valley Trunk Sewer.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- The Corporation is hereby authorized to acquire a limited interest in the nature of an easement over the lands set out on Schedule "A" attached hereto.
- 2. The Corporation is hereby authorized to acquire a limited interest in the nature of an easement over the lands described on Schedule "B" attached hereto which easement is to expire on the 1st day of July, 1981.
- 3. The Mayor and Clerk are hereby authorized to execute the Certificate of Approval on the Plan of Expropriation prepared by P.A. Blackburn, O.L.S. dated the 15th day of August, 1979.
- 4. This By-law shall come into force and effect upon being finally passed.
