BY-LAW NO. 146-90

A BY-LAW TO AMEND BY-LAW NO. 28-80 TO  
REZONE CERTAIN LANDS ON DREW STREET  
FROM A "RESIDENTIAL SECOND DENSITY (R.2)"  
ZONE TO A "RESIDENTIAL MULTIPLE FIRST  
DENSITY SPECIAL ZONE NO. 47 (RM.1 SP.47)"  
(JACQUES AND THIBEAULT - DREW STREET)

WHEREAS the owner of the subject property has requested a rezoning;

AND WHEREAS the Council of The Corporation of the City of North Bay has ensured that adequate information has been made available to the public, and has held at least one public meeting after due notice for the purpose of informing the public of this By-law;

AND WHEREAS it is deemed desirable to amend the zone designation shown on Schedule "B44" of By-law No. 28-80 pursuant to Section 34 of The Planning Act.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1) Schedule "B-44" of By-law No. 28-80 is amended by changing the zoning designation of the property shown on Schedule "A" attached hereto (which property is more particularly described as Lots 15-18, Plan M-161, Part 1, Plan 36R-8352 along Drew Street in the City of North Bay, shown as hatched on Schedule "B" attached hereto) from a "Residential Second Density (R.2)" zone to a "Residential Multiple First Density Special Zone No. 47 (RM.1 Sp.47)".
- 2) Section 11 of By-law No. 28-80 is amended by inserting at the end thereof the following Section:
  - 11.2.47 "Residential Multiple First Density Special Zone No. 47 (RM.1 Sp.47)"
    - 11.2.47.1 The property description of this "Residential Multiple First Density Special Zone No. 47 (RM.1 Sp.47)" is Lots 15-18, Plan M-161 and Part 1, Plan 36R-8352 along Drew Street in the City of North Bay as shown on the attached Schedule and Schedule "B-44".

11.2.47.2 No person shall use land, or use, erect or construct any building or structure in this "Residential Multiple First Density Special Zone No. 47 (RM.1 Sp.47)" zone, except for the following uses: a triplex dwelling and a double duplex dwelling.

11.2.47.3 The use of land or buildings in this "Residential Multiple First Density Special Zone No. 47 (RM.1 Sp.47)" shall conform to all other regulations of this By-law, except as hereby expressly varied."

- 3) Section 11 of By-law No. 28-80 is further amended by inserting "Schedule to Residential Multiple First Density Special Zone No. 47 (RM.1 Sp.47)" as shown on Schedule "C" to this By-law.
- 4) a) Notice of this By-law shall be given by the Clerk in the manner and form and to the persons prescribed by Ontario Regulation 404/83.
- b) Where no notice of appeal is filed with the Clerk of The Corporation of the City of North Bay within twenty (20) days after the day that the giving of written notice as required by the Act is completed, then this By-law shall be deemed to have come into force on the day it was passed.
- c) Where one or more notices of appeal are filed with the Clerk of The Corporation of the City of North Bay within twenty (20) days after the day that the giving of written notice as required by the Act is completed, setting out the objection to the By-law and the reasons


in support of the objection, then this By-law shall not come into force until all appeals have been finally disposed of, whereupon the By-law shall be deemed to have come into force on the day it was passed.

READ A FIRST TIME IN OPEN COUNCIL THE 7th DAY OF August 1990.

READ A SECOND TIME IN OPEN COUNCIL THE 17TH DAY OF SEPTEMBER 1990.

READ A THIRD TIME IN OPEN COUNCIL AND PASSED THIS 17TH DAY

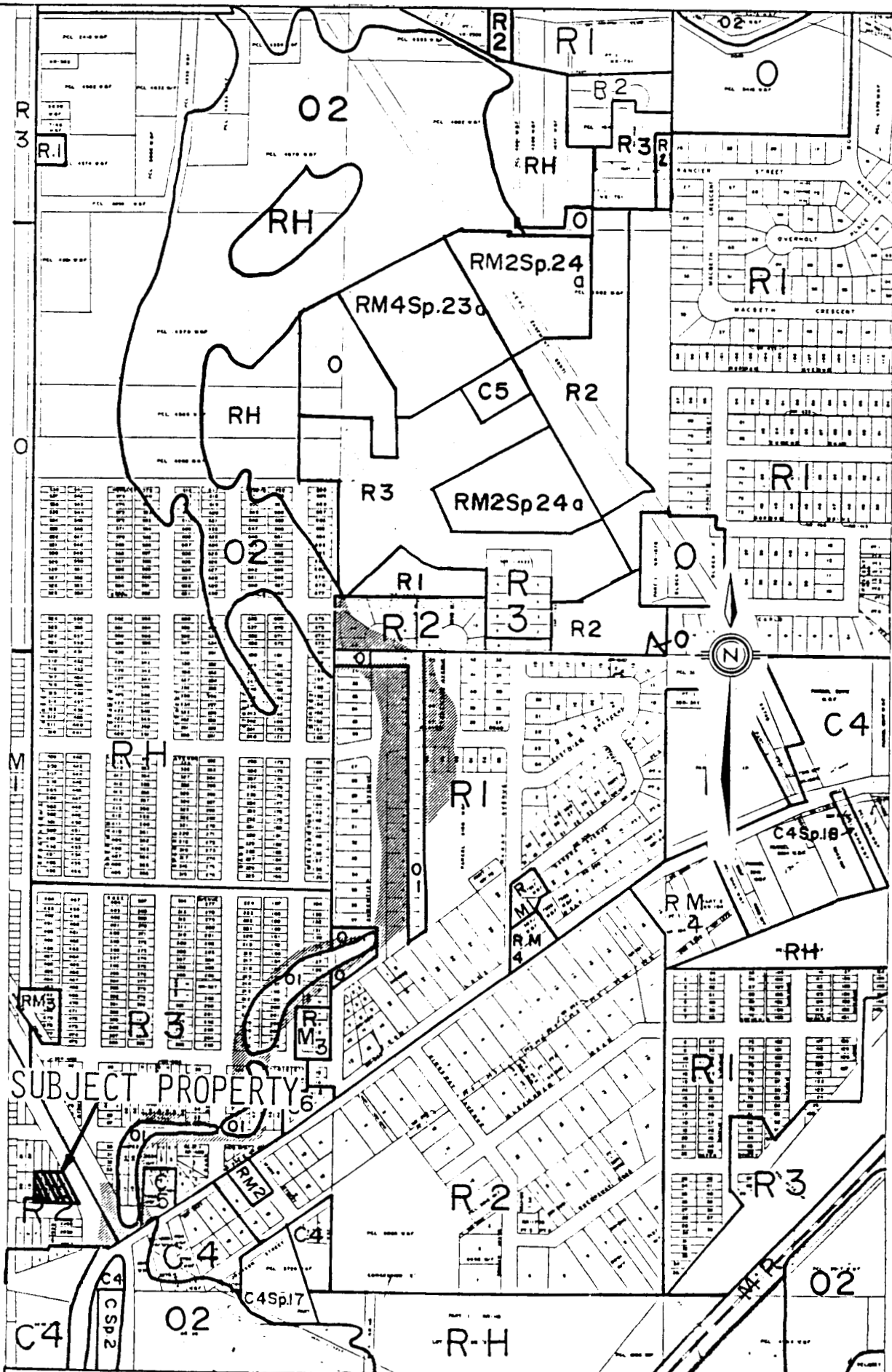

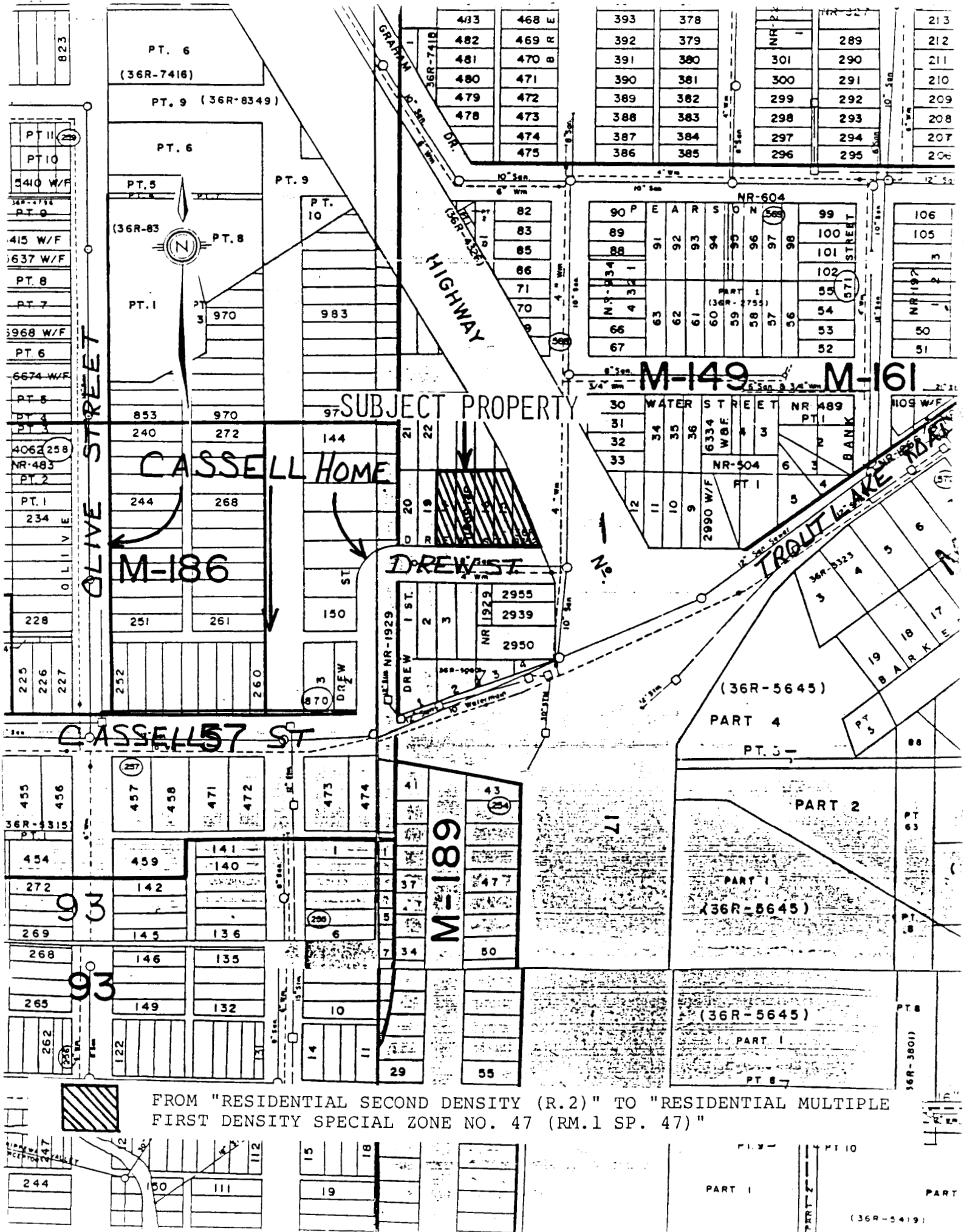

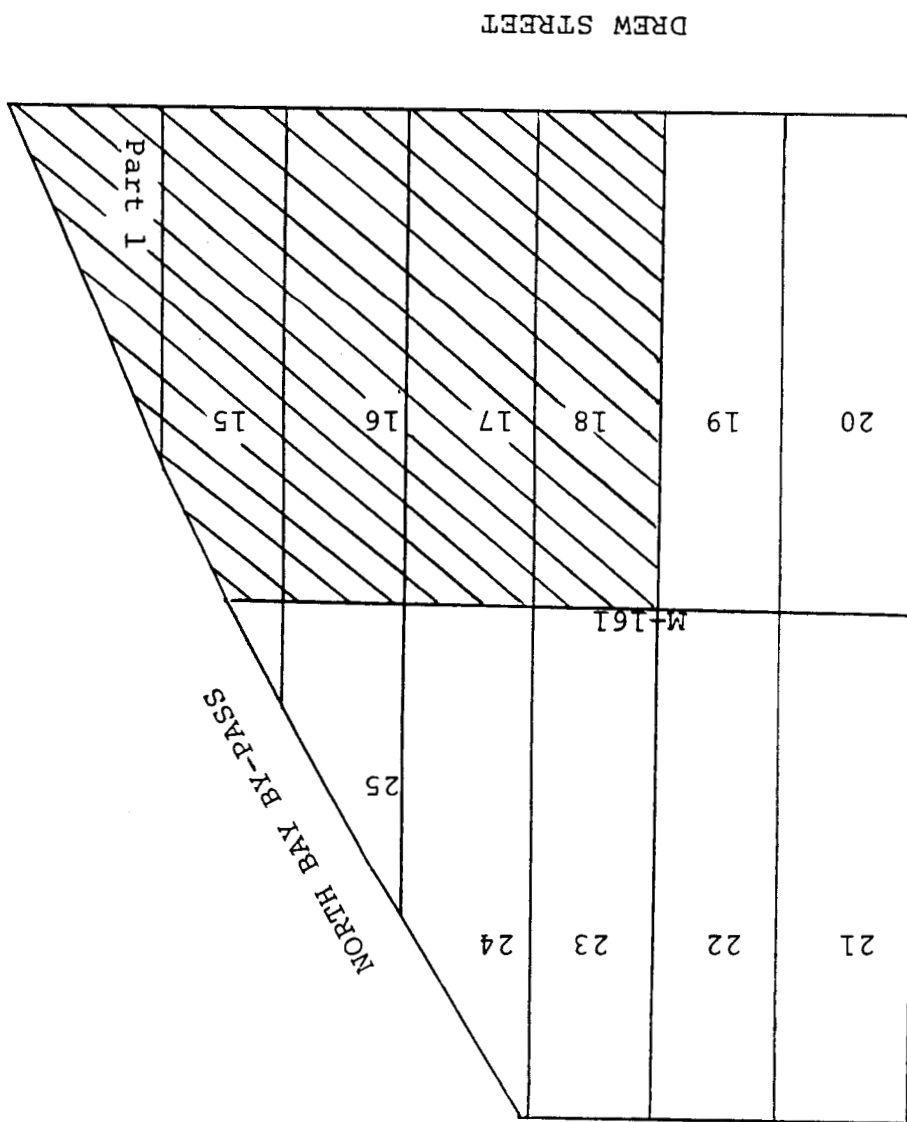
