BEING a By-Law to grant an Annual Retirement Allowance to certain Civic Employees.

WHEREAS a recommendation has been received from the North Bay Civic Employees Pension Committee to pay a retiring allowance to certain employees.

AND WHEREAS the said Municipal Council deem it advisable to grant such allowance in appreciation of long and faithful service to the Corporation by various employees.

THEREFORE UNDER THE PROVISIONS OF THE MUNICIPAL ACT BEING R.S.O. 1937 Chapter 266, Section 265 THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT the following employees be each paid a retiring allowance of

SIXTY-FIVE DOLLARS (\$65.00) per month:

- J. BOUCHER
- A. O. LAING
- N. CHAPUT
- J. PALANGIO
- W. E. CALLOWAY

2. THAT the said allowance would commence on January 1st, 1948 and be continued for life.
