

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 123-78

BEING A BY-LAW TO REVISE THE SALARIES AND EXPENSE ALLOWANCES OF THE ALDERMEN OF THE CITY OF NORTH BAY AND TO REPEAL BY-LAW NO. 50-74.

WHEREAS pursuant to the provisions of The Municipal Act, R.S.O. 1970, Chapter 284, Sections 389 and 392, the Council of the Corporation of the City of North Bay deems it advisable to revise the salaries and expense allowances payable to the Aldermen as aforesaid.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. (a) That each Alderman of the City of North Bay be paid an annual allowance effective 1 January, 1979, of \$4950.00 per annum and effective 1 January, 1980, each Alderman of the City of North Bay shall be paid an annual allowance of \$5197.50 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his duties as a member of the Council.
- (b) That in addition to the annual allowance payable to him as Alderman, the Deputy Mayor shall receive an additional allowance effective 1 January, 1979 of \$1650.00 per annum, and effective 1 January, 1980, \$1932.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his duties.
2. That in the event that an Alderman is absent in any year from more than five (5) regularly called meetings of Council or of Council in Committee, the sum of \$30.00 shall be deducted from the salary of such Alderman for each such meeting in excess of five (5); provided that such sum shall not be deducted in the case of an Alderman being absent from a meeting by reason of being required to attend elsewhere in the business of the City if such absence is authorized by a resolution of Council.
3. That the expense allowance herein set out shall be the only expenses to be allowed or paid to or for any Alderman other than travelling expenses allowable pursuant to by-law.
4. That the allowances herein set out shall be paid monthly not in advance.
5. That this By-law shall come into force upon the date on which the 1979-80 Council takes office.
6. That By-law No. 50-74 of the Corporation of the City of North Bay be and is hereby repealed.

READ A FIRST TIME IN OPEN COUNCIL THIS 23RD DAY OF OCTOBER, 1978.

READ A SECOND TIME IN OPEN COUNCIL THIS 6th DAY OF November 1978.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 6th DAY OF November, 1978.
