BEING a By-Law repealing By-Laws Numbers 639 and 707, and appointing a Fire Chief in the Town of North Bay, and setting the salaries to be paid the Fire Chief and the several Members of the Fire Department.

WHEREAS it is deemed advisable by the Municipal Council of the Corporation of the Town of North Bay to repeal By-Laws Numbers 639 and 707, and to appoint a Fire Chief in the Town of North Bay and setting forth the salaries to be paid the Fire Chief and tje several Members of the Fire Department.

THEREFORE, the Municipal Council of the Corporation of the Town of North Bay enacts as follows:-

1. THAT By-Laws Numbers 639 and 707 be and the same are hereby repealed.

2. THAT GEORGE M. BRADY, be and he is hereby appointed Fire Chief.

(a) That on resigning his position he must give the Corporation one Month's notice. Similar notice, except in cases of improper conduct, must be given him by the Corporation, if said Corporation desires to be relieved of his services.

3. THAT an Assistant Chief and Lieutenant shall be appointed by the Fire Chief.

4. THAT five regular firemen and four volunteers shall be retained and appointed by the Fire Chief.

5. THAT the salaries of officers and members of the Fire Department, payable on the 1st., and 15th of each month, shall be as follows:-

(a) The Fire Chief shall be paid at the rate of \$2140.00 Dollars per annum. 2400

(b) The Assistant Chief shall be paid at the rate of \$1620.00 Dollars per annum. 1680

(c) The Lieutenant shall be paid at the rate of \$1600.00 Dollars per annum. 1620

(d) Each Regular Fireman, with 2½ years service, shall be paid at the rate of \$1500.00 Dollars per annum.

(e) Each Regular Fireman hereafter engaged shall be paid a salary of Twelve Hundred and Sixty Dollars (\$1260.00) per annum, with a semi-annual increase of \$5.00 Per Month until the maximum of \$1500.00 Dollars is reached.

(f) Each volunteer fireman shall be paid One Hundred and Eighty Dollars (\$180.00) per annum.

6. One quarter of one month's salary shall be retained from each member of the Fire Department, as security for regular payment on fixed dates. ✓

7. THAT this By-Law shall be made effective retroactive to December the First, 1924.

Rules of Order were suspended and By-Law was read a third time short and passed this 22nd day of December, 1924.
