BY-LAW NO. 2002-86

**BEING A BY-LAW TO AUTHORIZE RENOVATIONS
AND COMPUTER UPGRADES TO THE NORTH BAY
PUBLIC LIBRARY IN THE CITY OF NORTH BAY**

WHEREAS the Municipal Act, R.S.O. 1990, Chapter **M-45**, Section 207, Paragraph 58(1), authorizes the Council to pass a by-law for the purposes therein stated;

AND WHEREAS the Council deems it desirable and necessary to pass the within by-law;

AND WHEREAS the Council passed Resolution No. 2002-396 at its meeting held July 8, 2002, approving the renovations and computer upgrades;


NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. That the renovations and computer upgrades to the North Bay Public Library **as** described in Schedule "A" attached hereto and forming part of this by-law in the amount of \$100,000.00 be hereby authorized.
2. That the Treasurer of the City of North Bay is hereby authorized to borrow from time to time from any bank or person by way of Promissory Note or Notes, temporary advances of money to meet the cost of repairs as aforesaid pending the completion thereof and pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowing exceed the amount of \$100,000.00 limited in this by-law.
3. Any promissory note or notes issued pursuant to paragraph 2 hereof shall be sealed with the seal of The Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.
4. That debentures to be issued when the work is completed to pay for the cost of such work shall bear interest at such rate **as** the Council may determine and shall be made payable within (15) years on the instalment plan.

READ A THIRD TIME IN OPEN COUNCIL, AND ENACTED AND PASSED THE 22ND DAY OF JULY 2002.
