

BY-LAW NO. 1216

BEING A BY-LAW to fix the Polling Places and appoint Deputy Returning Officers for the holding of Municipal Elections for the year 1936, in the Municipality of North Bay.

WHEREAS it is necessary to pass a By-Law fixing Polling Places and appointing Deputy Returning Officers for the purpose of taking the vote of the Electors, to select a Mayor and Ten (10) Aldermen (to be elected by general vote) to transact the Municipal affairs of the City, for the selection of Public School Trustees (One (1) from each Ward.)

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

- (1) THAT Polling Place No. 1 for the purpose of the said election shall be in W. Santary's Store, 382 Main Street West, and G.L. Riches and T. H. Winters are hereby appointed Deputy Returning Officers.
- (2) THAT Polling Place No. 2 for the purpose of the said election shall be in the Court House, Bye and McIntyre Streets, and D.J. Quinn and R.J. Peel are hereby appointed Deputy Returning Officers.
- (3) THAT Polling Place No. 3 for the purpose of the said election shall be in Jas. Palangio's Store, 38 Front Street, and G. Elmitt, and C.J. O'Grady and L. Thacker are hereby appointed Deputy Returning Officers.
- (4) THAT Polling Place No. 4 for the purpose of the said election shall be in H. T. Relph's residence, 145 Worthington Street West, and R. Colbon and H.T. Relph are hereby appointed Deputy Returning Officers.
- (5) THAT Polling Place No. 5 for the purpose of the said election shall be in the City Hall, McIntyre and Ferguson Streets, and E.J. Carter and E.B. Willis are hereby appointed Deputy Returning Officers.
- (6) THAT Polling Place No. 6 for the purpose of the said election shall be in the Canadian Legion Club Rooms, McIntyre and Ferguson Streets, and S.G. Stewart and A. Miller are hereby appointed Deputy Returning Officers.
- (7) THAT Polling Place No. 7 for the purpose of the said election shall be in the Orange Hall, Fisher and McIntyre Streets, and G.H. Newton and W. Childerhose are hereby appointed Deputy Returning Officers.
- (8) THAT Polling Place No. 8 for the purpose of the said election shall be in the Orange Hall, Fisher and McIntyre Streets, and D. King and H.R. Miller are hereby appointed Deputy Returning Officers.
- (9) THAT Polling Place No. 9 for the purpose of the said election shall be in P. Vizona's residence, 334 Main Street East, and J.M. White and W. Foster are hereby appointed Deputy Returning Officers.
- (10) THAT Polling Place No. 10 for the purpose of said election shall be in C.J. Corbett's residence, 215 Fisher Street, and C.J. Corbett, F. Tattersal and Alex Smith are hereby appointed Deputy Returning Officers.

(11) THAT Polling Place No. 11 for the purpose of the said election shall be at the Orange Hall, Cassells Street, between Third Avenue and Percy Street, and P.W. White, W.H. Quinn and A. Aubry are hereby appointed Deputy Returning Officers.

(12) THAT Polling Place No. 12 for the purpose of the said election shall be in T. H. Clarke's residence, 139 Front Street, and A.S. Waite and S.J. Chamberlain are hereby appointed Deputy Returning Officers.

(13) THAT Polling Place No. 13 for the purpose of the said election shall be in E. C. Bebee's residence, 399 Cassells St. and W.A. Frizzel and E.C. Bebee are hereby appointed Deputy Returning Officers.

(14) THAT the Railway Employees, Express Messengers and Commercial Travellers Advance Polling Place for the purpose of said election shall be in the City Hall, Ferguson and McIntyre Streets and A.C. Amos is hereby appointed Deputy Returning Officer.

(15) THAT the City Clerk shall attend the Council Chambers at the hour of Twelve Noon on the 3rd. day of December, A.D.1935 for the final summing up of the number of votes for the Mayor and Aldermen.

READ a Second Time in Open Council this 4th. day of November, 1935.
