BY-LAW NO. 115-78

BEING A BY-LAW TO AMEND BY-LAW NO. 1097
OF THE CORPORATION OF THE CITY OF NORTH BAY.

WHEREAS upon the request of the property owner concerned and with the approval of the local Planning Board, it is considered advisable to amend By-law No. 1097 of the former Township of Widdifield to provide for an alteration to the zone designation as shown on "The District Map" which forms part of said By-law No. 1097.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. The District Map of By-law No. 1097 of the former Township of Widdifield is amended by changing the zoning designation of the lands shown on Schedule "B" attached hereto and forming part hereof, (being Part of Parcel 8397 W&F in the North Half of Lot 5, Concession 1, of the former Township of Widdifield, which property is more particularly shown as hatched on Schedule "C" attached hereto and forming part hereof), from "Bush District...B" to an "Industrial Special Zone 14-78

(ISp. 14-78)" as designated on Schedule "B".

2. Regulations:

For the purposes of this By-law, all buildings or structures erected or altered and the use of land in such "Industrial Special Zone 14-78 (ISp. 14-78)" hereby established shall conform to the uses and regulations set forth in Schedule "A" attached hereto and forming part hereof.

3. All buildings and structures erected or altered in the zones hereby established shall conform to Zoning By-law No. 1097 of the former Township of Widdifield, except as hereby expressly varied.

4. This By-law shall take effect from the date of passing by Council, and shall come into force upon the approval of the Ontario Nunicipal Board.






