

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 84-69

BEING A BY-LAW TO PROVIDE FOR THE PROTECTION,
MAINTENANCE, ENJOYMENT, AND CONTROL OF PARKS,
PLAYGROUNDS, FLOWERED AREAS, AND CERTAIN MUNI-
CIPAL BUILDINGS WITHIN THE CITY OF NORTH BAY.

WHEREAS the parks, playgrounds, flowered areas, and municipal buildings used in conjunction therewith, owned by and situated within the City of North Bay are for the use, benefit, and pleasure of the public and it is desirable to prevent any person from interfering with such use, benefit, and pleasure.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

The terms "park" and "parks" used herein shall include all lands within the City of North Bay laid out, designated, maintained, or recognized by The Corporation of the City of North Bay as parks playgrounds, flowered areas, and other lands of like nature; all waters contained within or passing through such lands; and all buildings situate on such lands or used in conjunction therewith.

"City" shall mean The Corporation of the City of North Bay.

"Person" shall include an individual, a partnership, a body corporate, and a club or other organization.

Words in the singular shall include the plural, and vice versa; and this by-law shall be read and construed as though the grammatical and terminological changes rendered necessary in either case had been made.

The headings of sections set out herein are for the purpose of description and convenience, and shall not be read so as to limit the application of the sections to which they refer.

1. It shall be unlawful for any person, unless so authorized by the City, to commit or attempt to commit within any park any of the acts hereinafter set forth:

DAMAGE

1. Cut, climb, break, injure, deface or disturb any tree, shrub, plant, rock, building, cage, pen, monument, fence, bench, apparatus or property; pluck, pull up, cut, take or remove any shrub, bush, plant or flower, or injure any grass; or mark or write upon any building, monument, fence, bench, or other structure.

REMOVAL OF TURF, WOOD, ETC.

2. Cut or remove any wood, turf, grass, soil, rock, sand or gravel.

ANIMALS

3. Lead or let loose any animal or fowl of any kind, provided that this prohibition shall not apply to a dog when led by a cord or chain not more than six (6) feet long.

HORSES

4. Ride or drive any horse or other animal not well broken and under effective control of the rider or driver; or ride or drive at a speed exceeding ten miles per hour; or ride or drive on any drive, track or path, not specifically provided for such purpose by the City.

MOTOR-DRIVEN VEHICLES

5. Operate any motor-driven vehicle elsewhere than on such roads or drives as are specifically designated for such purpose by the City.

FASTENING ANIMALS

6. Hitch or fasten any horse or other animal except at such place or places designated for such purpose by the City.

SWIMMING, ETC.

7. Swim, bathe or wade in any water except where it is designated for such purpose by the City; or introduce any substance, material, or matter into said water which causes or can reasonably be expected to cause pollution thereof.

FIRES

8. Make or kindle a fire for any purpose, except in places provided therefor by the City.

AIR GUNS, FIREARMS FIREWORKS, ETC.

9. Carry or discharge any firearms, fire-crackers, rockets, torpedoes, bows and arrows, air guns, catapults or fireworks.

CAMPING AND PICNICS

10. Camp or lodge or hold any picnic at any place not designated for such purpose by the City.

SALE OR DISPLAY OF MERCHANDISE, ETC.

11. Sell, or offer for sale, or display, any merchandise or article whether for immediate or future delivery, or any art, skill or service to be exercised or performed immediately or in the future, without the written permission of the City.

TRADE AND BUSINESS

12. Practice, carry on, conduct or solicit for any trade, occupation, business or profession, without the written permission of the proper officer of the City duly authorized to grant such permission.

PLACE FOR GAMES

13. Play or engage in any team game, except at such places as shall be set apart for the purpose by the City.

GAMBLING

14. Play or bet at or against any game conducted, dealt or carried on with cards, dice or other devices, for money, chips, shells, credit, or any other representative of value, or maintain or exhibit any gambling table or other instrument of gambling or gaming.

TRUCKS AND DRAYS

15. Drive or have any dray, truck, wagon, car, perambulator, or other traffic vehicle, carrying or regularly used or employed in carrying goods, merchandise, lumber, machinery, oil, manure, dirt, sand or soil, or any article of trade or commerce, or any offensive article or material whatever, upon any road or drive, except such drive or drives as is specifically provided or designated for such use by the City.

POSTING NOTICES, ADVERTISING, ETC.

16. Distribute any handbills or circulars, or post, place, or erect, any bills, notices, or paper or advertising device or matter of any kind without the written consent of the City.

KILLING, ETC., OF BIRDS, FOWL AND ANIMALS

17. Disturb, molest, wound, kill or attempt to kill any bird, fowl or animal, or remove or injure any bird's nest or eggs.

NO ADMITTANCE SIGNS

18. Enter any place where the sign "NO ADMITTANCE" or sign of like effect is displayed.

TRAFFIC CONGESTION

19. Leave standing any vehicle upon a drive or any part thereof, if by doing so it congests traffic or obstructs the road, or, being the owner of such vehicle, allow or permit the same to so stand.

VEHICLES FOR HIRE AND SOLICITING

20. Park any vehicle for the purpose of soliciting passengers for compensation, or, being the owner of such vehicle, allow or permit the same to be parked for such purpose.

DISORDERLY CONDUCT

21. Indulge in boisterous, threatening, indecent, or riotous conduct; or abusive, threatening, profane, or indecent language.
22. Being a male person, accost, annoy or in any way interfere with any female person.

NUISANCE

23. Create a nuisance by loitering, spying, frightening, annoying, or generally making himself, herself or themselves objectionable to other persons.
24. Commit any disorderly or immoral act or endeavour to entice any person from public view.

BICYCLES

25. Violate any of the rules of the road established by municipal by-law or Ontario Provincial Statute in respect of ownership and operation of bicycles.
26. (a) Operate a bicycle unless the same is equipped with a bell which can be distinctly heard within a distance of thirty (30) yards.

- (b) Operate a bicycle unless the same is equipped with a front white light and a red light in the rear.
- (c) Operate a bicycle with more than one other bicycle travelling abreast thereof.
- (d) Operate a bicycle on the grass.
- (e) Coast with a bicycle, or operate a bicycle except with both hands on the handles thereof.
- (f) Carry any infant or children on any bicycle in any manner whatever.
- (g) Exceed a speed of five (5) miles per hour when riding a bicycle.

GAMES

- ...27..... Engage in any play at baseball, cricket, shinny, football, tennis, croquet, or any other games, or foot races or horse races, except upon grounds designated by the City for such purposes; or engage in such games within twenty (20) feet of any drive.

DISPOSAL OF REFUSE, BOTTLES, ETC.

28. Scatter, drop, or leave, except in a receptacle provided for the deposit of refuse therein, any piece of paper, rags, garbage, dead flowers, empty bottles or any glass article or broken glass or rubbish of any kind.

ANNOYANCE OF PLAYERS

29. Interfere with, annoy, or make unseemly remarks to, any person engaged in games.

SKATING

30. (a) Use in any skating rink long nosed racing skates, unless the same are protected by toe-guards of a type approved by the City.
- (b) Race or speed so as to endanger or interfere with any other person using a rink.
- (c) Carry a cane or stick of any kind upon the ice except upon rinks provided for, and at such times as are set aside for, the playing of hockey.
31. Refuse to abide by and follow the rules or regulations relating to the use of any park, or the directions and orders of any employee of the City whose duties include the care, maintenance or supervision of any park.
2. Every person who contravenes any of the provisions of this by-law shall be guilty of an offence punishable under the provisions of The Summary Convictions Act and shall pay at the discretion of the convicting Judge a fine not exceeding, exclusive of costs, the sum of fifty dollars (\$50.00) for each such offence. All fines or penalties imposed pursuant to this by-law shall, unless otherwise provided, be paid to the City.
