BY-LAW NO. 2004-203

**BEING A BY-LAW TO AUTHORIZE THE FUNDING OF THE
AIRPORT HILL WATER SYSTEMS ANALYSIS (ZONES 3 & 4) PROJECT**

WHEREAS the *Municipal Act, 2001* (S.O. 2001, c-25), Section 326 authorizes the Council to pass a by-law for the purposes therein stated;

AND WHEREAS the *Municipal Act, 2001* (S.O. 2001, c-25), Section 401 authorizes the Council to pass a by-law for the purposes herein stated;

AND WHEREAS the Council passed Resolution 2004-837 at its meeting held November 29, 2004, authorizing the expenditure of funds for the Airport Hill Water Systems Analysis (Zone 3 & Zone 4) Project, being Project #W61, with a net debenture cost of \$230,000.00;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That the expenditure of \$230,000.00 for the Airport Hill Water Systems Analysis (Zone 3 & Zone 4) Project for the following be hereby authorized:

Total estimated expenditures	\$ 650,000.00

Funding reallocated from Capital Project 2252WS	(\$300,000.00)
Funding from Zone 4 Special Impost Fee Reserve Fund	(\$90,577.00)
Funding from Development Charges Reserve Fund	<u>(\$29,423.00)</u>
Net Amount to be Debentured	\$ 230,000.00

2. That the Treasurer of the City of North Bay is hereby authorized to borrow from time to time from any bank or person by way of promissory note or notes temporary advances of money to meet the cost of work as aforesaid pending the completion thereof and pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowings exceed the amount of \$230,000.00 limited in this by-law.
3. Any promissory note or notes issued pursuant to paragraph 2 hereof shall be sealed with the seal of The Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.
4. That the debentures to be issued when the work is completed to pay for the cost of such work shall bear interest at such rate as the Council may determine and shall be made payable within fifteen (15) years and shall be a charge against all rateable property in the Urban Service Area of The Corporation of the City of North Bay, to such an extent as to repay the principal and interest on a principal amount not to exceed \$230,000.00.

READ A SECOND TIME IN OPEN COUNCIL THIS 13TH DAY OF DECEMBER, 2004.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 13TH DAY OF DECEMBER, 2004.
