

BY-LAW NO. 1784

BEING A BY-LAW to amend By-Law No. 1456, a By-Law known as the Zoning By-Law.

AND WHEREAS the Municipal Council of the City of North Bay deems it advisable to amend By-Law No. 1456.

BY-LAW 1456 is amended and the following shall be enacted.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That Schedule "B", Paragraph (4) of Zoning By-Law No. 1456 be amended and the following added thereto.

"Excepting thereto and therefrom that part described as follows: That Area contained within the boundaries of Lots 59 and 48 on Main St. West to the North and the Easterly side of Timmins Street on the West and Lots Block "B" and Lots 1, 2, 3, 4, 5 & 6 on Harriet Street to the South and the Easterly boundary of Lot 6 Harriet Street and the projection thereof across a lane to the rear of Lots 1, 2, 3, 4, 5, & 6 to the East thence along the Northerly boundary of said lane to the North of Lots 2, 3, 4, 5 & 6 on Harriet Street, to the North, thence along the Easterly boundary of Lot 59 to its intersection with Main Street."

2. That Schedule "D" be amended to add the area described as follows:

"That area contained within the boundaries of Lots 59 and 48 on Main St. West to the North and the Easterly side of Timmins Street on the East and Lots Block "B" and Lots 1, 2, 3, 4, 5, & 6 on Harriet Street to the South and the Easterly boundary of Lot 6 on Harriet Street and the projection thereof across a lane to the rear of Lots 1, 2, 3, 4, 5, & 6 to the East thence along the Northerly boundary of said lane to the North of Lots 2, 3, 4, 5, & 6 on Harriet Street. To the North thence along the Easterly boundary of Lot 59 to its intersection with Main Street."

3. That Schedule "C" Paragraph (6) a By-Law No. 1456 be amended and the following added thereto.

"Excepting therefrom that part described as follows:

That Block contained by the boundaries of First Street to the East, Rear Street to the North, Second Street to the West and Harriet and Main Streets to the South."

4. That Schedule "C" be amended to add the area described as follows:

"That Block contained by the boundaries of First Street to the East, Rear Street to the North, Second Street to the West and Harriet Street and Main Street to the South."
