BEING a By-law for the revision of Salaries in the City of North Bay.

WHEREAS it is deemed advisable that the Salaries of the Aldermen of the City of North Bay be revised.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY PURSUANT TO CHAPTER 266 of the Revised Statutes of Ontario and Amendments thereto ENACTS AS FOLLOWS:

1. That each duly elected alderman of the City of North Bay be paid the annual remuneration of **THREE HUNDRED DOLLARS** (\$300.00) per year, which said sum shall be payable quarterly. PROVIDED, however, that there shall be a deduction, of SEVEN DOLLARS (\$7.00) from each Alderman for each meeting of Council not attended by him and a further deduction of ~~THREE DOLLARS~~ (\$5.00) for each Committee Meetings not attended.
2. That should any Alderman be absent from sufficient meetings of Council or Committee Meetings during the first, second or third quarters so that the deductions made pursuant to Clause 1 of this By-law exceeds the amount of that quarterly indemnity such difference shall be carried over to the subsequent quarters.
3. That should the amount of deductions charged to any Alderman made pursuant to Clause 1 exceed the amount of his annual remuneration he shall not be liable for such amount exceeded by him.
4. That this By-law shall come into force and effect on the first day of January, 1945.
5. That By-law be presented to the Department of Municipal Affairs for their approval.
