- 3. That Clause No. 10 of By-Law No. 239-90 be amended by deleting the figure \$168,000.00 in the fifth line thereof and inserting in lieu thereof the figure \$215,000.00.
- 4. That this By-Law shall not become effective until approval in writing has been received from the Ontario Municipal Board pursuant to Section 64(1) of the Ontario Municipal Board Act, R.S.O. 1980, Chapter 347.
