

**THE CORPORATION OF THE CITY OF NORTH BAY**

**BY-LAW NO. 2007-137**

**BEING A BY-LAW TO APPOINT  
MUNICIPAL BY-LAW ENFORCEMENT OFFICERS**

**WHEREAS** section 7.1(1) of the *Fire Protection and Prevention Act, 1997* allows municipalities to pass by-laws regulating open air burning and fire routes;

**AND WHEREAS** section 1(3) of the *Provincial Offences Act* allows a Minister of the Crown to designate in writing certain persons as Provincial Offences Officers;

**AND WHEREAS** the Solicitor General has designated all employees of Municipalities whose duties include the enforcement of by-laws as Provincial Offences Officers for the purposes of by-law offences;

**AND WHEREAS** section 15(1) of the *Police Services Act* allows municipal councils to appoint persons to enforce the by-laws of their municipality;

**AND WHEREAS** in order to issue Part 1 tickets pursuant to the *Provincial Offences Act*, for open air burring and fire route violations, the City's Fire Prevention Officers are required to be designated as Municipal By-law Enforcement Officers;

**AND WHEREAS** the Council passed Resolution 2007-401 at its Meeting held Monday, June 11, 2007, authorizing the appointment of all Fire Prevention Officers as Municipal By-law Enforcement Officers for the purposes of enforcing the City of North Bay by-laws relating to open air burning and fire routes.

**NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS;**

1. That the following Fire Prevention Officers are hereby appointed as Municipal By-law Enforcement Officers for the purpose of enforcing the City of North Bay by-law relating to open air burning and fire routes, for so long as they continue to be employed by the City of North Bay of North Bay in that capacity:

Randy Vezina	Chief Fire Prevention Officer
Joseph Gardiner	Fire Prevention Officer
Sheri Korn	Fire Prevention Officer.

2. This by-law shall come into force and effect upon being passed.
