

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 72-68

Being a by-law authorizing the installation of a sewer connection from the existing sewer main to Lot 27 as shown on Plan M-235 for the City of North Bay registered in the Registry Office for the Registry Division of the District of Nipissing, situate in the City of North Bay and known as Municipal No. 314 Lakeside Drive, North Bay, Ontario, at the expense of the owner of such property.

WHEREAS Mrs. Betty Ann Horner, owner of the above-described land and premises, is desirous of having the Corporation of the City of North Bay install the necessary sewer connection from the existing City sewer main to the aforesaid property at a cost not exceeding the sum of One Thousand and Five Dollars (\$1,005.00);

AND WHEREAS Mrs. Betty Ann Horner aforesaid is unable to pay the aforesaid cost and expenses at once, and is desirous of paying the aforesaid cost with interest at the rate of 6% on the deferred payment in successive annual payments extending over a period of five (5) years and that such annual payments be added by the Clerk of the Corporation of the City of North Bay to the Collector's Roll and collected in like manner as Municipal Taxes;

AND WHEREAS the North Bay Area Health Unit by reason of the unsanitary condition of the existing septic tank on the aforesaid land and premises and by reason of the fact that the aforesaid property is situate in low lying area unsuitable for a septic tank has recommended that the aforesaid sewer connection be installed pursuant to Section 24 of The Public Health Act, R.S.O. 1960, Chapter 321, as amended.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That the necessary sewer connection be installed from the existing City sewer main to the above-described property at a cost not exceeding the sum of One Thousand and Five Dollars (\$1,005.00), and that the cost thereof, including interest at the rate of 6% on the deferred payments be paid by the owner of the said property, Mrs. Betty Ann Horner, aforesaid in equal, successive, annual payments extending over a period of five (5) years and that such annual payments be added by the Clerk of the Corporation of the City of North Bay to the Collector's Roll and collected in like manner as Municipal Taxes.

READ A SECOND TIME IN OPEN COUNCIL THIS 23RD DAY OF SEPTEMBER, 1968.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 23RD DAY OF SEPTEMBER, 1968.
