## THE CORPORATION OF THE CITY OF NORTH BAY

## **BY-LAW NO. 2000-58**

BEING A BY-LAW TO PROVIDE FOR THE LEVY AND COLLECTION OF SPECIAL CHARGES IN RESPECT OF CERTAIN BUSINESS IMPROVEMENT AREAS

**WHEREAS** subsection 220(17) of the *Municipal* Act, as amended, provides that the council of a municipality shall in each year levy a special charge upon rateable property in a business improvement area which has been designated under subsection 220(1); that is in a prescribed business property class sufficient to provide a sum equal to the sum of money provided for the purposes of the board of management for that area, together with interest on the sum at such rate as is required to repay any interest payable by the municipality on the whole or any part of such sum.

## THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. There shall be levied and collected for the purposes of the Board of Management of the Downtown Improvement Area, amounts calculated for each prescribed business property class and subclass set out in Column II, on the assessment of real property in a prescribed business property class rateable for such purposes as set out in Column III, the special charge rate set out on Column IV which shall produce the total special charge for the business improvement area set out in Column V:

- 2. Notwithstanding Section 1 hereof and pursuant to By-Law No. 47-94,
  - (a) no person with a business property address on Main Street shall pay a special charge levied herein for the 2000 calendar year of more then \$2,500.00 upon each business assessment.
  - (b) no person with a business property address not on Main Street shall pay a special charge levied herein for the 2000 calendar year of more than \$1,500.00 upon each business assessment.
- 3. The special charge rated and imposed pursuant to the provisions of the By-Law shall become due and payable in two equal instalments, namely on June 30, 2000 and September 29, 2000.

4. The Tax Collector and the Treasurer of The Corporation of the City of North Bay are hereby authorized to collect the said special charges in the same manner and with the same remedies as provided in the *Municipal* Act for the collection of taxes upon business assessment.
