## BY-LAW NO. 2009-234

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF AGREEMENTS BETWEEN THE CORPORATION OF THE CITY OF NORTH BAY AND DISTRICT OF NIPISSING SOCIAL SERVICES ADMINISTRATION BOARD RELATING TO A FUNDING AGREEMENT FOR OFFICE RENOVATIONS AND A TEN YEAR LEASE OF  $1^{\rm ST}$ ,  $2^{\rm ND}$  AND  $3^{\rm RD}$  FLOOR OFFICE SPACE TOGETHER WITH A LEASE OF TEMPORARY SPACE IN THE LOBBY AND  $7^{\rm TH}$  FLOOR OF CITY HALL

WHEREAS the agreements with the District of Nipissing Social Services Administration Board for a new ten year lease, interim space allocation lease and funding agreement for office renovations was approved by Resolution No. 2009-536 passed on the 10<sup>th</sup> day of August, 2009;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. The Corporation of the City of North Bay enter into an agreement with the District of Nipissing Social Services Administration Board dated the 1<sup>st</sup> day of April, 2010 relating to a new ten year lease for the 3<sup>rd</sup>, 4<sup>th</sup> floor and part of the 1<sup>st</sup> floor space at City Hall.
- 2. The Corporation of the City of North Bay enter into an agreement with the District of Nipissing Social Services Administration Board relating to the lease of temporary space in the lobby and the 7<sup>th</sup> floor of City Hall.
- 3. The Corporation of the City of North Bay enter into an agreement with the District of Nipissing Social Services Administration Board dated the 1<sup>st</sup> day of August, 2009 relating to a funding agreement for District of Nipissing Social Services Administration Board office renovations.
- 4. That the Mayor and Clerk of The Corporation of the City of North Bay are hereby authorized to execute these agreements between The Corporation of the City of North Bay and District of Nipissing Social Services Administration Board and to affix thereto the corporate seal.
