BY-LAW NO. 230-86

BEING A BY-LAW TO REPEAL CERTAIN BY-LAWS
WHICH ARE NO LONGER IN FORCE IN THE CITY
OF NORTH BAY

WHEREAS the Annexation Order of the Ontario Municipal Board entered on December 28, 1967 declared that the By-laws then in force in the Township of Widdifield and in the Township of West Ferris shall remain in force in such areas until such time as such by-laws then in force are repealed or amended by the Council of the enlarged City of North Bay;

AND WHEREAS it is now deemed desirable to repeal certain by-laws which are no longer in force or which have been superseded by other legislation.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:
