

THE CORPORATION OF THE CITY OF NORTH BAYBY-LAW NO. 123-74

BEING A BY-LAW PASSED PURSUANT TO THE PROVISIONS OF THE LOCAL IMPROVEMENT ACT, R.S.O. 1970, CH. 255, SECTION 8, DECLARING IT IS DESIRABLE THAT THE CONSTRUCTION OF A 30 FT. WIDE ASPHALT ROADWAY WITH CONCRETE CURB AND GUTTER AS DESCRIBED IN SCHEDULE "A" TO THIS BY-LAW SHOULD BE UNDERTAKEN AS A LOCAL IMPROVEMENT.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Pursuant to the provisions of The Local Improvement Act, R.S.O. 1970, Chapter 255, Section 8, it is hereby declared it is desirable that the construction of a 30 foot wide asphalt roadway as specified and described in Schedule "A" attached hereto and forming part of this By-law should be undertaken as a local improvement.

READ A SECOND TIME IN OPEN COUNCIL THIS 18TH DAY OF DECEMBER, 1974.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 18TH DAY OF DECEMBER, 1974.

BY-LAW NO. 122-74

BEING A BY-LAW AUTHORIZING THE EXECUTION OF THAT CERTAIN AGREEMENT DATED THE 25TH DAY OF NOVEMBER, 1974 BETWEEN THE CORPORATION OF THE CITY OF NORTH BAY AND THE NORTH BAY PROFESSIONAL FIRE FIGHTERS' ASSOCIATION, LOCAL 284, INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS, RELATING TO AN AGREEMENT FOR SALARIES AND WORKING CONDITIONS.


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. THAT the Corporation of the City of North Bay do enter into that certain agreement dated the 25th day of November, 1974 between The Corporation of the City of North Bay and the North Bay Professional Fire Fighters' Association, Local 284, International Association of Fire Fighters, upon and subject to the terms and conditions set forth in the said Agreement.

2. THAT the Mayor and Clerk be and they are hereby authorized and empowered to execute the aforesaid Agreement dated the 25th day of November 1974 on behalf of the Corporation of the City of North Bay and to affix thereto the Corporate Seal.
