

BY-LAW NO. 1299

Not Approved.

BEING A BY-LAW to amend By-Law No. 890 which By-Law deals with Water Rates to be charged to Water Users in the City of North Bay.

WHEREAS the Council of the Corporation of the City of North Bay deem it advisable to amend By-Law No. 890 as amended by By-Law No. 994 and By-Law No. 1111.

THEREFORE BE IT ENACTED AND IT IS HEREBY ENACTED BY THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY AS FOLLOWS:

1. THAT in lieu of the present Schedule B of By-Law No. 890 and Clause No. 3 of By-Law 1111, which are hereby repealed, the following Schedule B shall be substituted.

SCHEDULE "B"

Tariff of Water Rates for Metered Water Users

(a) Railway rates - net.

Canadian Pacific Railway, 10¢ per 1000 gallons,
Temiskaming & Northern Ontario Railway, 11¢ per
1000 gallons.

Canadian National Railway, 12¢ per 1000 gallons.

(b) Except for those water users mentioned in sub-section (a) of this Schedule B, the tariff of water rates shall be as follows:

First 50,000 gallons used in any month	25¢ per 1000 gals.
Second 50,000 " " " " "	23¢ per 1000 gals.
Balance used in any month	19¢ per 1000 gals.

(c) The minimum yearly charge on meter basis (exclusive of meter rental) shall be \$20.00.

(d) Water Users coming under sub-section (b) of this Schedule B shall be allowed a discount of 10% for payment made within fifteen days of billing of account.

2. THAT Schedule A of By-Law No. 890 be amended by adding the following classifications and rates:

(a) Circuses including any side shows attached to the Circus \$25.00 per day for each day water is used.

(b) Travelling Carnivals, Sideshows or Menageries requiring water on show grounds \$5.00 per day for each day water is used.

(c) Private Greenhouses \$5.00 annually.

(d) Shower Baths (in Tourist Cabins) \$3.00 annually for first bath; \$2.00 annually for each additional bath.

(e) Tourist Cabins (without service) \$2.50 annually.

3. THAT in lieu of Clause 60 of By-Law No. 890 which is hereby repealed, the following shall be substituted.

The yearly rental for meters supplied by the Corporation shall be as follows:

3/4 "	3.00
1 "	4.00
1 1/2 "	8.00
2 "	12.00
3 "	30.00
4 "	50.00
4 " (compound)	50.00
6 "	100.00

4. Except for sub-sections (a) and (c) of above Schedule B, By-Law No. 994 shall not apply to the rates herein named in this By-Law.

5. THAT this By-Law shall become effective from the First day of January, 1939.

READ A SECOND Time in Open Council this 17th day of October, 1938.

Rules of Order be suspended and By-Law read a Third Time short and passed this 17th day of October, 1938.
