BY-LAW NO. 105-91

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW
NO. 57-89 (SCHEDULE 2 - NO PARKING
ANYTIME; SCHEDULE 17 - TRAFFIC CONTROL
SIGNALS)

WHEREAS the Municipal Act, R.S.O., 1980, Chapter 302, as amended,
authorizes the Council to pass By-Laws regulating or prohibiting
certain traffic on highways and regulating or prohibiting parking
on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1980, Chapter 198,
as amended, authorizes the Council to pass By-Laws regulating
traffic on highways.

NOW THEREFORE THE CORPORATION OF THE CITY OF NORTH BAY HEREBY
ENACTS AS FOLLOWS:


