THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 191-82

BEING A BY-LAW TO AUTHORIZE CONSTRUCTION OF STORM SEWERS ON MAIN STREET FROM CASSELLS STREET TO SHERBROOKE STREET IN THE CITY OF NORTH BAY AND TO IMPOSE A SPECIAL RATE.

WHEREAS the Municipal Act, R.S.O. 1980, Chapter 302, sections 210~(78) authorizes the Council to pass a by-law to establish, operate and maintain works necessary for a sewer system.

AND WHEREAS the Council deems it desirable to undertake the installation of a storm sewer on Main Street in the City of North Bay;

AND WHEREAS the Municipal Act, section 143 authorizes the municipality to borrow money by the issue of instalment debentures and to impose a rate on such property as may be specified in the by-law.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That storm sewers be constructed on the streets in the City of North Bay described in Schedule "A" attached hereto and forming part of this by-law.
- 2. The Engineering Department of the City of North Bay be instructed to make all necessary plans, profiles and specifications forthwith and to furnish such information as may be necessary for the making of a contract for the execution of the work or for the carrying on of the work by day labour.
- 3. That the work shall be carried on under the superintendence of and according to the directions and orders of the Engineering Department of the City of North Bay.
- 4. That the Council may decide by resolution to carry on and execute the work by day labour.
- 5. That in the absence of a resolution by Council, the work be carried on and executed by day labour.
- 6. The Mayor and Clerk are hereby authorized to enter into a contract with some person or persons, firm or corporation for the construction of the work subject to the approval of the work by resolution.
- 7. That the Treasurer of the City of North Bay is hereby authorized to borrow from time to time from any bank or person by way of Promissory Note or Notes, temporary advances of money to meet the completion thereof and pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowing exceed the amount limited in this by-law.
- Any promissory note or notes issued pursuant to paragraph 7 hereof shall be sealed with the seal of The Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.

- 9. The debentures to be issued when the work is completed to pay for the cost of such work shall bear interest at such rate as the Council may determine and shall be made payable within fifteen (15) years on the instalment plan and shall be a charge against the lands in the Urban Service Area established by By-law No. 68-71, as amended, of The Corporation of the City of North Bay to such an extent as to repay the principal and interest on a principal amount not to exceed \$315,000.00.
- 10. There is hereby imposed upon all the rateable property in the Urban Service Barea established by By-law No. 68-71, as amended, of the City of North Bay, a sewer rate for a period of fifteen (15) years, sufficient to pay the interest and principal amount of \$315,000.00 for the construction of the works as follows:
 - (a) a mill rate on the assessed value of all land in the Urban Service Area designed by By-law No. 68-71, as amended, of The Corporation of the City of North Bay.
- 11. That this by-law shall not become effective until approval in writing has been secured from the Ontario Municipal Board, pursuant to Section 64 (1) of the Ontario Municipal Board Act, R.S.O. 1980, chapter 347.

Description of Work

Construction of approximately 2320 feet of 15 inch to 27 inch diameter sewer along Main Street and 490 feet of 30" to 36" diameter outfall sewer on Ferguson Street from Main Street to the existing sewer on C.P.R. property complete with service connections and other appurtenances.

Estimated cost of Construction	\$411,000.

Total Estimated Cost of Construction	\$515,000.
Less H.I.A. Subsidy	\$200,000.
Net Debentured Cost	\$315,000.
