THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 198-88

BEING A BY-LAW TO STOP UP AND CLOSE A PORTION OF CARRUTHERS STREET BETWEEN MOFFAT AND ABER-DEEN AVENUES IN THE CITY OF NORTH BAY.

WHEREAS it is deemed expedient and in the interest of The Corporation of the City of North Bay and that part of the street hereinafter described be closed and stopped up;

AND WHEREAS notice of this By-law was published once a week for four consecutive weeks in the North Bay Nugget, published in the City of North Bay;

AND WHEREAS no person has claimed that his lands will be prejudicially affected by the passing of this By-law nor applied to be heard in person or by his counsel, solicitor or agent, by the Council of the said City or a Committee of said Council.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That part of Carruthers Street, as shown on Registered Plan M-177 in the City of North Bay, in the District of Nipissing and more particularly described as Parts 1, 2 and 3, Plan 36R-7834, is hereby closed and stopped up.
- 2. The City shall transfer Part 1, Plan 36R-7834 to Henri Belanger and Irene Belanger for the sum of \$1.00 plus disbursements subject to the condition that any boundary fence shall be erected at the sole expense of Henri Belanger and Irene Belanger.
- 3. The City shall transfer Part 2, Plan 36R-7834 to Armand Duguay and Deirdre Duguay for the sum of \$1.00 plus disbursements subject to the condition that any boundary fence shall be erected at the sole expense of Armand Duguay and Deirdre Duguay. .
- 4. The City shall transfer Part 3, Plan 36R-7834 to Melvin O'Bright and Beverley O'Bright, for the sum of \$1.00 plus disbursements subject to the condition that any boundary fence shall be erected at the sole expense of Melvin O'Bright and Beverley O'Bright.
- 5. This By-law comes into force and effect upon a certified copy of this By-law being registered in the Land Registry Office for the District of Nipissing.
