

BY-LAW NUMBER 896

Being a By-Law to change the name of Kennedy Avenue from Judge Avenue to Golf Street to "Memorial Drive."

WHEREAS certain representations have been made to name a Street or Drive within the corporation of the City of North Bay in honor of the men who died in the Great War, 1914-1918.

AND WHEREAS the Street or Avenue chosen with this end in view is the Easterly Part of Kennedy Avenue commencing at a point on the Westerly boundary of Judge Avenue, and extending in a Westerly direction along the centre line of Kennedy Avenue a distance of 1351 feet to a point, where the pavement turns in a Northerly direction towards Golf Street; and that part of the Highway extending from Kennedy Avenue to the Bridge over Chippewa Creek at Golf Street, to "Memorial Drive"

THEREFORE, THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

THAT the said Easterly portion of Kennedy Avenue commencing at a point on the Westerly boundary of Judge Avenue, and extending in a Westerly direction along the centre line of Kennedy Avenue a distance of 1351 feet to a point, where the pavement turns in a Northerly direction towards Golf Street; and that part of the Highway extending from Kennedy Avenue to the Bridge over Chippewa Creek at Golf Street be named and is named "Memorial Drive."

THAT this By-Law take effect on the date of the final passing thereof.
