BY-LAW NO. 34-93

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW
NO. 57-89 (SCHEDULE 8 - THROUGH HIGHWAYS)
(SCHEDULE 19 - NO PARKING ANYTIME - WINTER
SEASON).

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M, as amended,
authorizes the Council to pass By-Laws regulating or prohibiting
certain traffic on highways and regulating or prohibiting parking
on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1990, Chapter H-8, as
amended, authorizes the Council to pass By-Laws regulating
traffic on highways.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
NORTH BAY HEREBY ENACTS AS FOLLOWS:
