

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2002-68

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 131-93 SCHEDULE 10 (STOP SIGNS - CARTIER STREET & CHAMPLAIN STREET) AND SCHEDULE 14 (SPEED LIMITS - WALLACE ROAD AND WICKSTEAD AVENUE) IN THE CITY OF NORTH BAY

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45, as amended, authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass by-laws regulating traffic on highways;

AND WHEREAS it is deemed expedient to regulate or prohibit certain traffic and to regulate or prohibit certain parking within the limits of the City of North Bay;

AND WHEREAS the Council of the City of North Bay passed Resolution No. 2002-296 at its meeting held June 3, 2002 and Resolution No. 2002-275 at its meeting held May 21, 2002, approving amendments to four way stops and reducing the speed limit on Wallace Road and Wickstead Avenue;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That Schedule 9 to Traffic By-law 131-93 is hereby amended by deleting the following:

SECTION C

Table with 3 columns: ROAD, FROM, TO. Row 1: Cartier Street, McKeown Avenue, Champlain Street. Row 2: Champlain Street, Hearst Street, McKeown Avenue.

- 2. That Schedule 10 to Traffic By-law No. 131-93 be amended by adding the following:

Cartier Street and Champlain Street on all four approaches

- 3. That Schedule 14 to Traffic By-law No. 131-93 is hereby amended by adding the following:

B. - LOWER RATE OF SPEED

Table with 3 columns: ROAD, BETWEEN, KILOMETRES PER HOUR. Row 1: Wallace Road, Wickstead Avenue and K&K Drive, 40 km/hr. Row 2: Wickstead Avenue, Wallace Road & Mountainview Drive, 40 km/hr.
