

BY-LAW NO. 1791

BEING A BY-LAW to amend By-law No. 1784.

AND WHEREAS the Municipal Council of the City of North Bay deems it advisable to amend By-law No. 1784.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

That Paragraph 4, By-law No. 1784 be amended to read as follows:

(1) That Schedule "D" be amended to add the area described as follows:



That Block contained by the boundaries of First Street to the East, Rear Street to the North, Second Street to the West and Harriett and Main Street to the South.

(2) This By-law shall come into effect upon its approval by the Ontario Municipal Board.

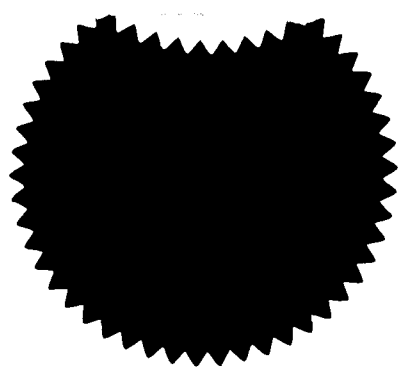
