THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 197-88

BEING A BY-LAW TO AMEND BY-LAW 53-79 REGARDING PARKING ON PRIVATE OR MUNICIPAL PROPERTY, TRAFFIC BY-LAW 2-82 AND HANDI-CAPPED PARKING BY-LAW 28-85.

WHEREAS the Parking Authority of the City of North Bay was terminated as of December 31, 1987.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- Paragraph 7 (b) (i) of By-law 53-79 is hereby amended by deleting the words "the Parking Authority" and inserting in lieu thereof the words "The Corporation".
- 2. Section 1 (d) of By-law No. 28-85 is hereby amended by deleting paragraph (d) and inserting in lieu thereof the following:
 - ""Parking Manager" means the person appointed from time to time by the council to be the Parking Manager."
- 3. Section 1 (e) of By-law 28-85 is hereby amended by deleting the words "Parking Authority" in the second line thereof and inserting in lieu thereof the words "Parking Manager".
- 4. Section 2 of By-law 28-85 is hereby amended by deleting the words "the Parking Authority" and inserting in lieu thereof the words "the Parking Manager".
- 5. Section 12 of By-law 28-85 is hereby amended by identifying the first paragraph thereof as paragraph (a) and inserting the following paragraph (b):
 - "(b) "When a vehicle is found parked or stopped in contravention of the provisions of this by-law, the Police Officer or Officer or Agent of The Corporation of the City of North Bay so finding the vehicle may issue a summons or offence notice or attach to the vehicle a parking ticket in the form of a serial numbered notice stating:
 - (1) the licence number or permit of the vehicle;
 - (2) the date, time, place and nature of the alleged offence;
 - (3) the procedure for making a voluntary payment of the penalty, which voluntary payment shall not be less than the prescribed amount set out in section 11 (a) and section 12 of this by-law;

- (4) In the event of the failure to make payments as required within three weeks, exclusive of costs, process will be issued pursuant to the Summary Convictions Act, or under the Provincial Offences Act, whichever is applicable."
- 6. Section 32 (2) of Traffic By-law No. 2-82 is hereby amended by deleting the words "Parking Authority" and inserting in lieu thereof the words "the Parking Manager".
