BEING A BY-LAW TO AMEND BY-LAW NO. 131-93 (SCHEDULE 2 - NO PARKING ANYTIME; SCHEDULE 3 -NO PARKING AREAS AT ANYTIME - WINTER MONTHS; SCHEDULE 5 - NO PARKING ANYTIME - RESTRICTED TIMES; SCHEDULE 6 - PARKING PROHIBITED FOR RESTRICTED PERIODS; SCHEDULE 9 - THROUGH HIGHWAYS; SCHEDULE 10 - STOP SIGNS; SCHEDULE 12 -SPEED LIMITS.

WHEREAS the Municipal Act, R.S.O., 1990, Chapter M-45, as amended, authorizes the Council to pass By-Laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-Laws regulating traffic on highways.
