

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 3-88

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 2-82;  
SCHEDULE 2 (PARKING PROHIBITION), SCHEDULE 8  
(THROUGH HIGHWAYS), AND SCHEDULE 15 (LOADING ZONES).

WHEREAS the Municipal Act, R.S.O. 1980, Chapter 302, as amended, authorizes the Council to pass By-Laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1980, Chapter 198, as amended, authorizes the Council to pass By-Laws regulating traffic on highways;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule 2 to Traffic By-Law No. 2-82 is hereby amended by adding the following:


