BY-LAW NO. 76-79

BEING A BY-LAW TO CLOSE TEMPORARILY A PORTION
OF WORTHINGTON STREET.

WHEREAS Contract Number 116-79 of the City of North Bay provides for the reconstruction of the street herein described;

WHEREAS the Municipal Act, R.S.O. 1970, Chapter 284, Sec. 352, Par. 60 provides for the temporary closing of any highway or portion thereof.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. a) Worthington Street shall be closed between Wyld Street and Ferguson Street during the hours of 12:01 a.m. 28 May, 1979 to 11:59 p.m. 1 September, 1979.
b) The City Engineer is authorized to close the portion of the street herein described at any time during the period specified provided the provisions of the Municipal Act, R.S.O. 1970, Chapter 284, Sec. 352, Par. 60 are complied with.
2. The provisions of the Municipal Act R.S.O. 1970, Chapter 284, Section 352, Paragraph 60 shall apply to the portion of the Highway closed by this by-law.
